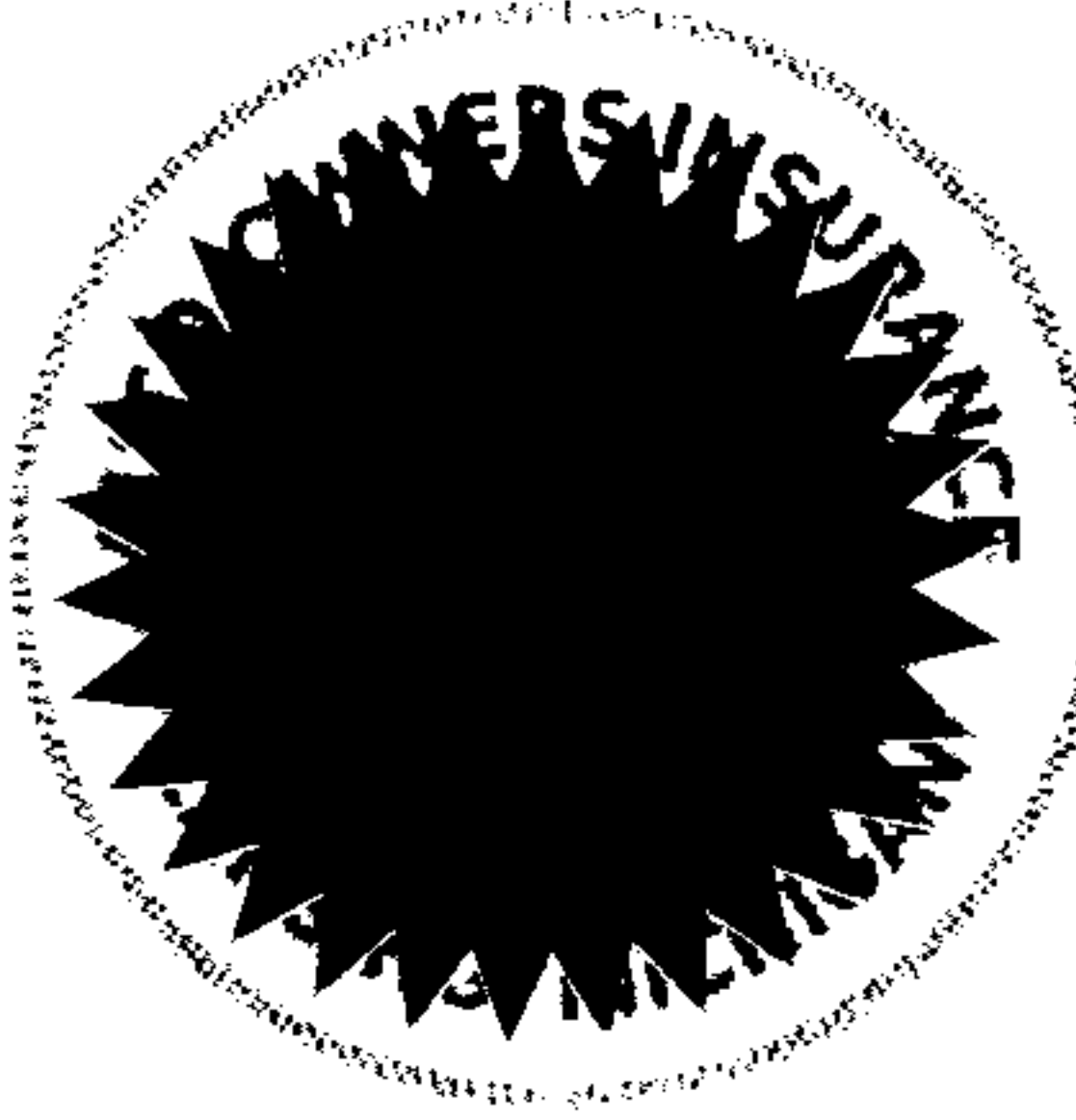

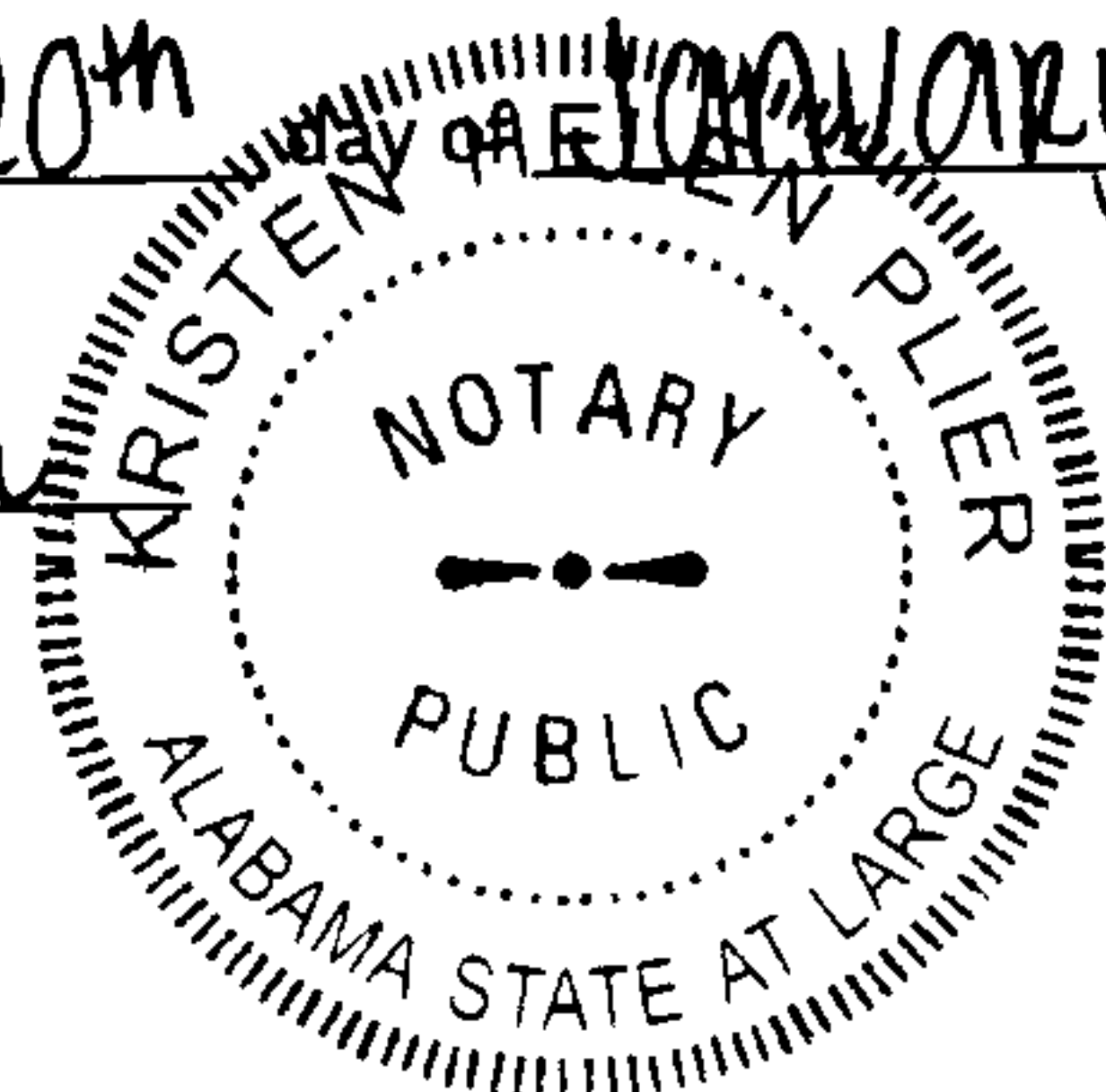
OATH OF OFFICE
