AN ORDINANCE TO AMEND APPENDIX A – ZONING – ARTICLE XII – R-A APARTMENT DWELLING DISTRICT – SECTION 2 – PERMITTED USES AND SECTION 4 – PROHIBITED USES OF THE CODE OF ORDINANCES OF THE CITY OF PELHAM

WHEREAS, the City of Pelham has determined that it is in the best interest of the City to amend Appendix A – Zoning – Article XII – R-A Apartment Dwelling District – Section 2 – Permitted Uses and Section 4 – Prohibited Uses of the Code of Ordinances – City of Pelham, Alabama, which is contained within and is a part of Ordinance No. 135-182, thereto as hereinafter set out.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Pelham, Alabama, that Appendix A – Zoning - Article XII – R-A Apartment Dwelling District - Section 2 - Permitted Uses and Section 4 – Prohibited Uses of the Code of Ordinances of the City of Pelham shall be and is hereby amended as follows:

Appendix A – Zoning-Article XII – R-A Apartment Dwelling District, Section 2 - Permitted Uses

Section One: Adding a new number (2) and renumbering Section 2:

(2) Home occupations in accordance with the requirements set forth in Article XXV, Section 6, detailed use regulations, home occupation

Appendix A – Zoning-Article XII – R-A Apartment Dwelling District, Section 2 - Prohibited Uses

Section Two: Deleting Item Number 4 and renumbering Section 4:

(4) Delete: Home Occupations

Section Three: Each of the provisions of this ordinance is severable; and if any provision shall be declared to be invalid, the remaining provisions shall not be affected but shall remain in full force and effect.

Section Four: All ordinances or parts of ordinances, in any manner conflicting herewith are hereby repealed.

Section Five: This ordinance shall become effective upon its passage and publication or posting as required by law.
