Know All Men by These Presents: That in consideration of **Two Hundred Sixty-Seven Thousand Six Hundred Sixty and 00/100 Dollars (\$267,660.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **SDH ALABAMA, LLC, a Georgia Limited Liability Company, formerly known as SDH BIRMINGHAM, LLC, a Georgia Limited Liability Company** (herein referred to as Grantor) grant, bargain, sell and convey unto **CYNTHIA STURDIVANT HASKINS and JOEL S. \$262,811.00 of the purchase price herein above has been paid by a purchase money mortgage loan closed simultaneously herewith.

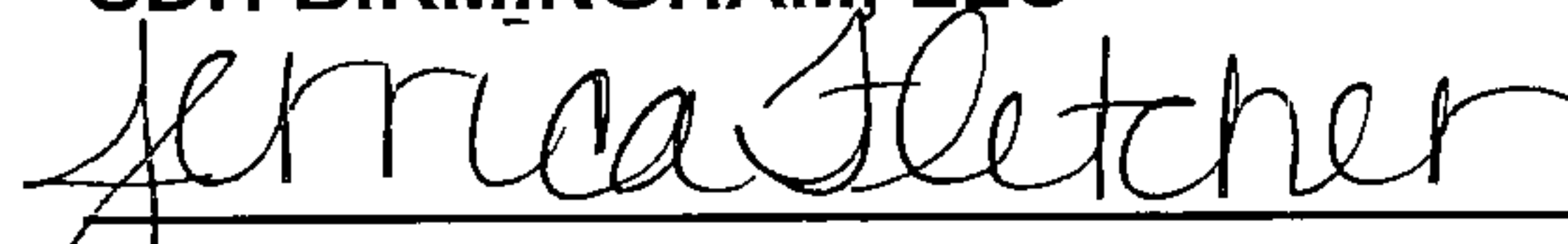
This instrument is executed as required by the Articles of Organization and Operating Agreement and same have not been modified or amended.

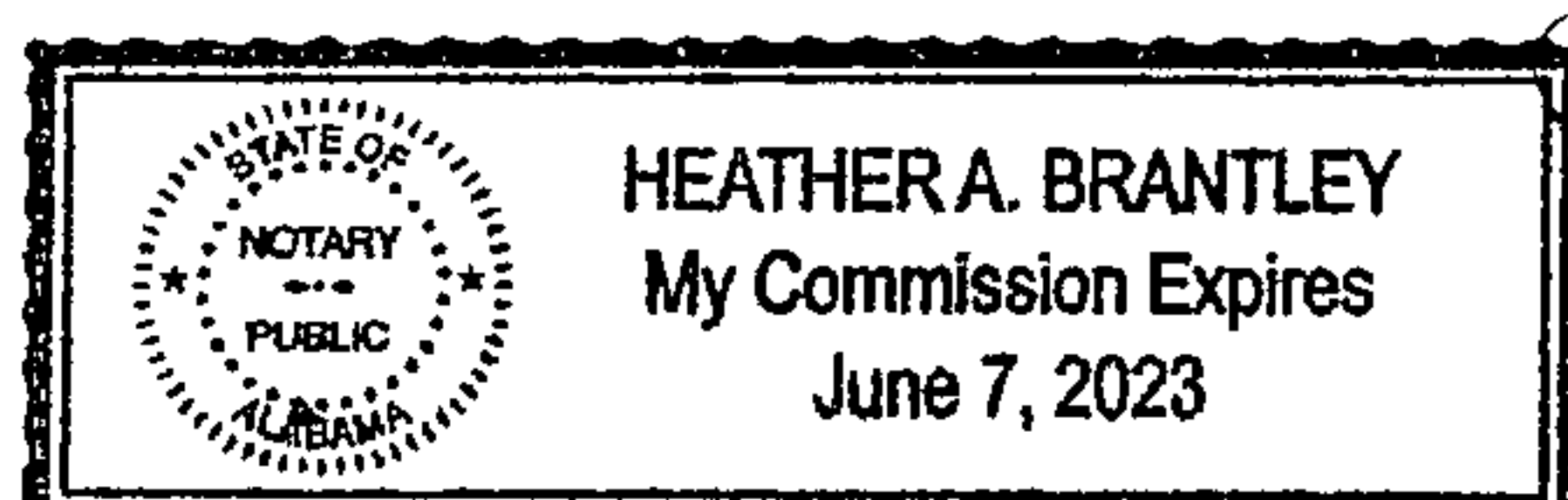

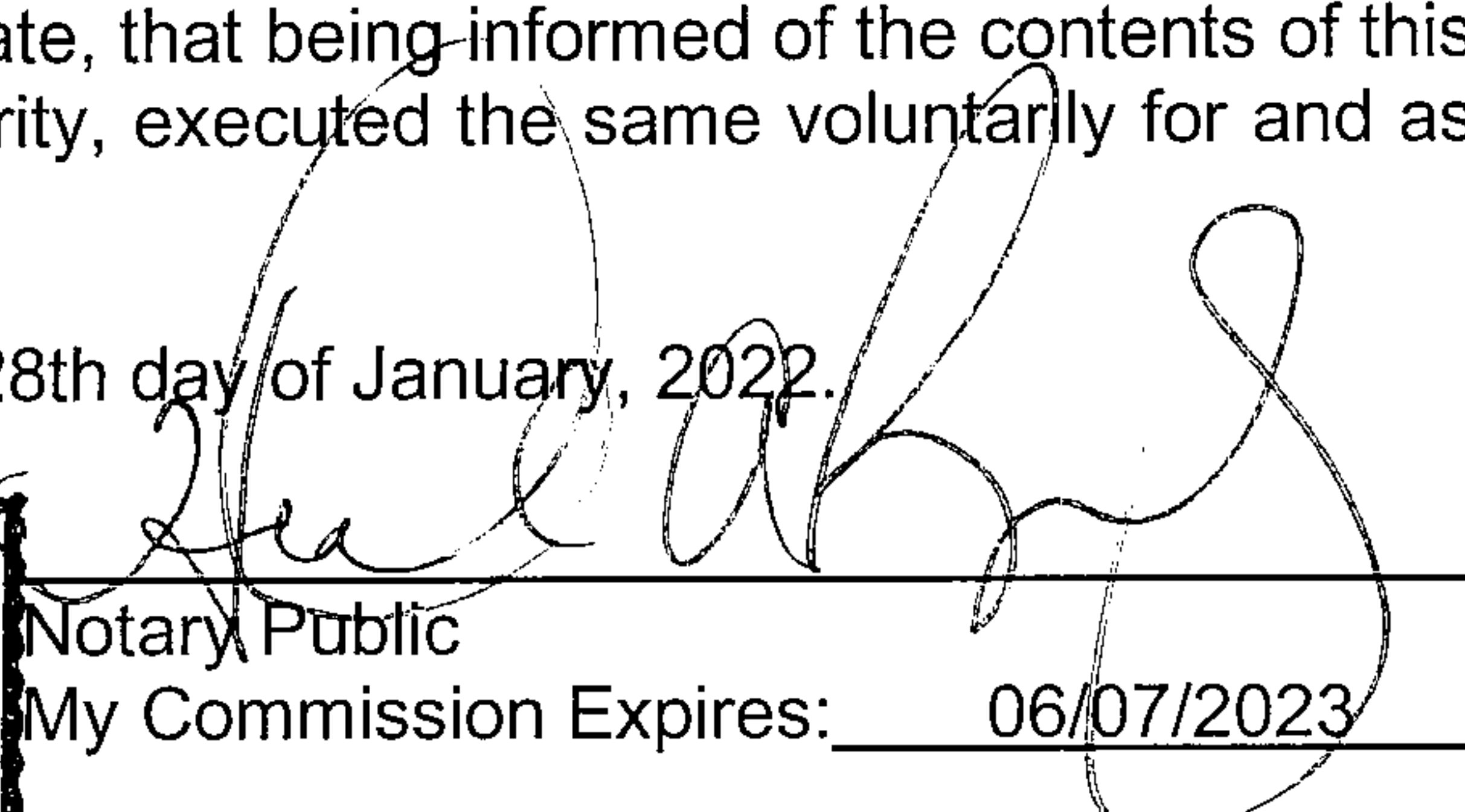
