Know All Men by These Presents: That in consideration of **One Hundred Seventy-Seven Nine Hundred and 00/100 Dollars (\$177,900.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, I, **JEFFRY WEAVER**, a **married man** (herein referred to as Grantor), grant, bargain, sell and convey unto **WILLIAM COOGAN and DAWN COOGAN** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

This property does not constitute the homestead of the grantor as defined in §6-10-3, Code of Alabama (1975).

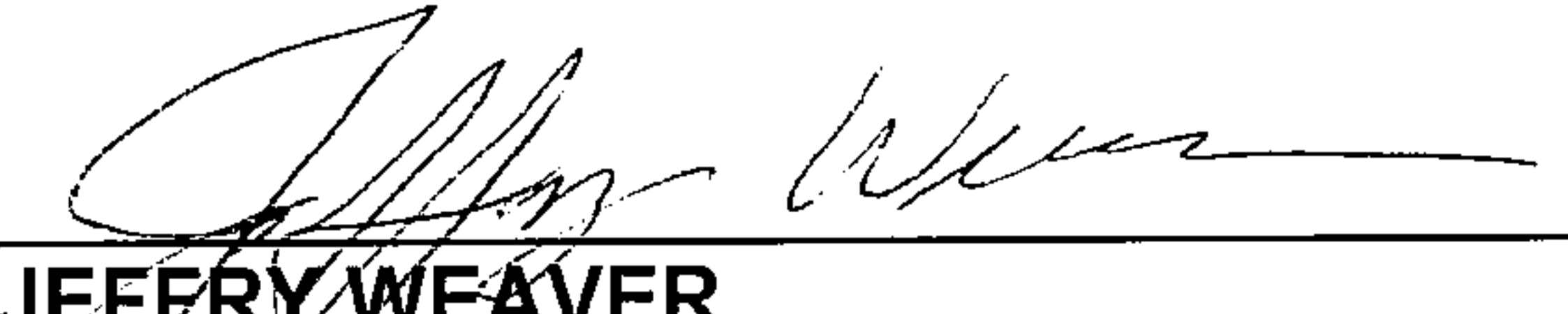
Subject to mineral and mining rights if not owned by Grantors. Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.

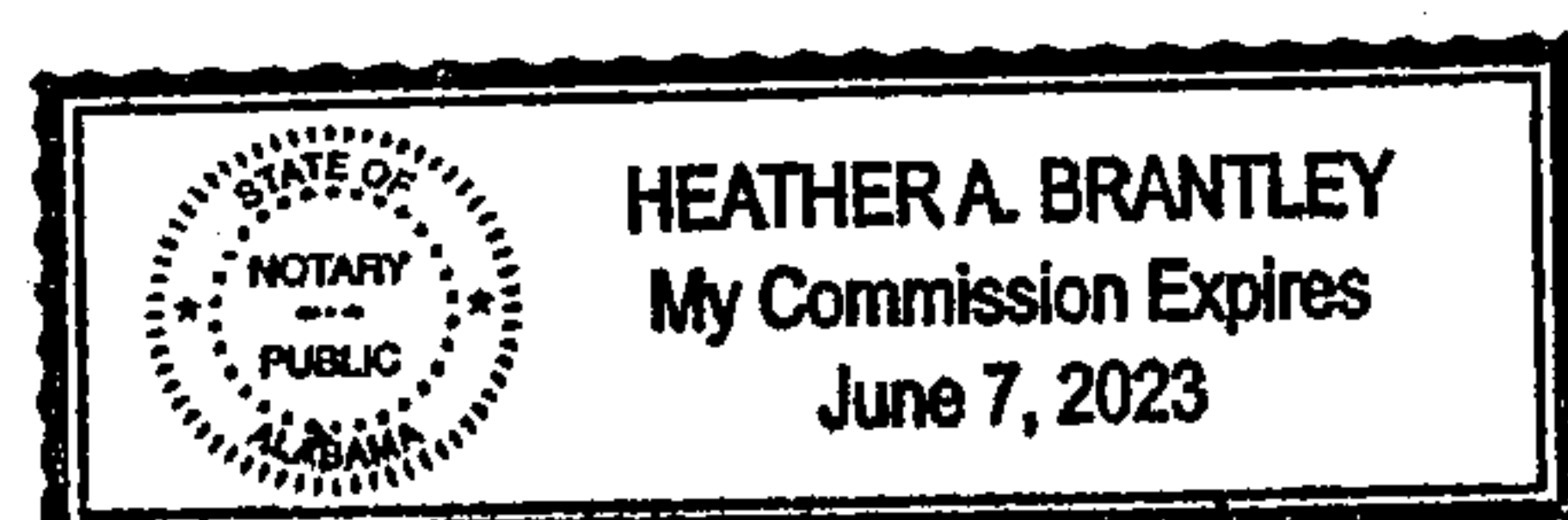

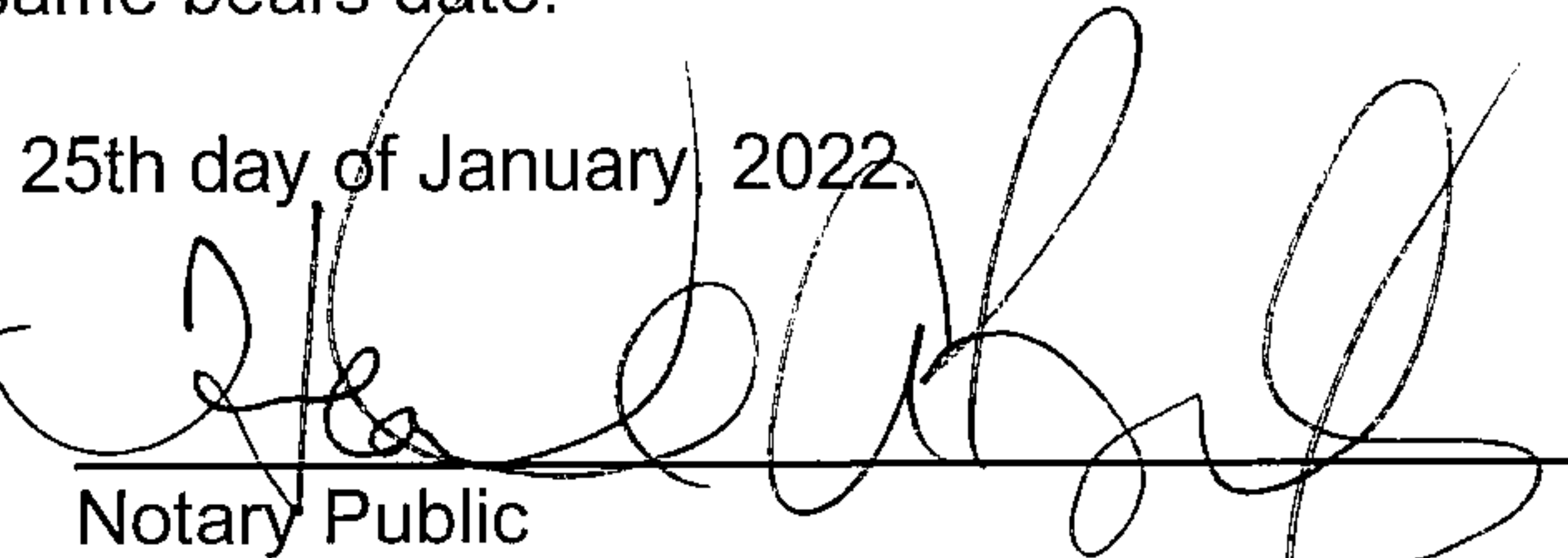

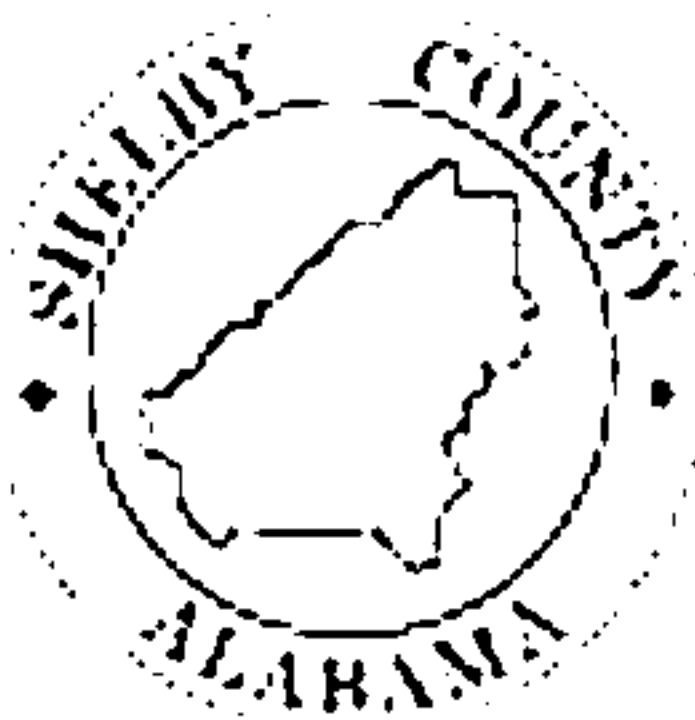
