That in consideration of **FIVE HUNDRED SIXTY FIVE THOUSAND FOUR HUNDRED FORTY FIVE AND 00/100 DOLLARS (\$565,445.00)** to the undersigned grantor, **Lake Wilborn Partners, LLC, an Alabama Limited Liability Company**, (herein referred to as GRANTOR) in hand paid by the grantees herein, the receipt whereof is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto **Jonathan C. Splaine and Ashley B. Splaine**, (herein referred to as Grantees), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

SUBJECT TO ALL MATTERS OF RECORD

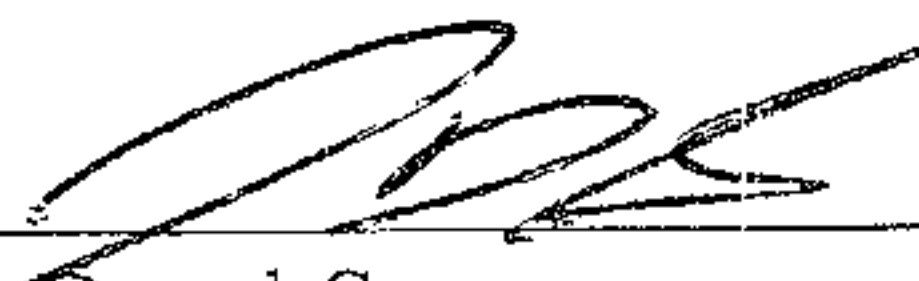
\$367,539.00 of the purchase price recited above has been paid from the proceeds of a mortgage loan closed simultaneously herewith.

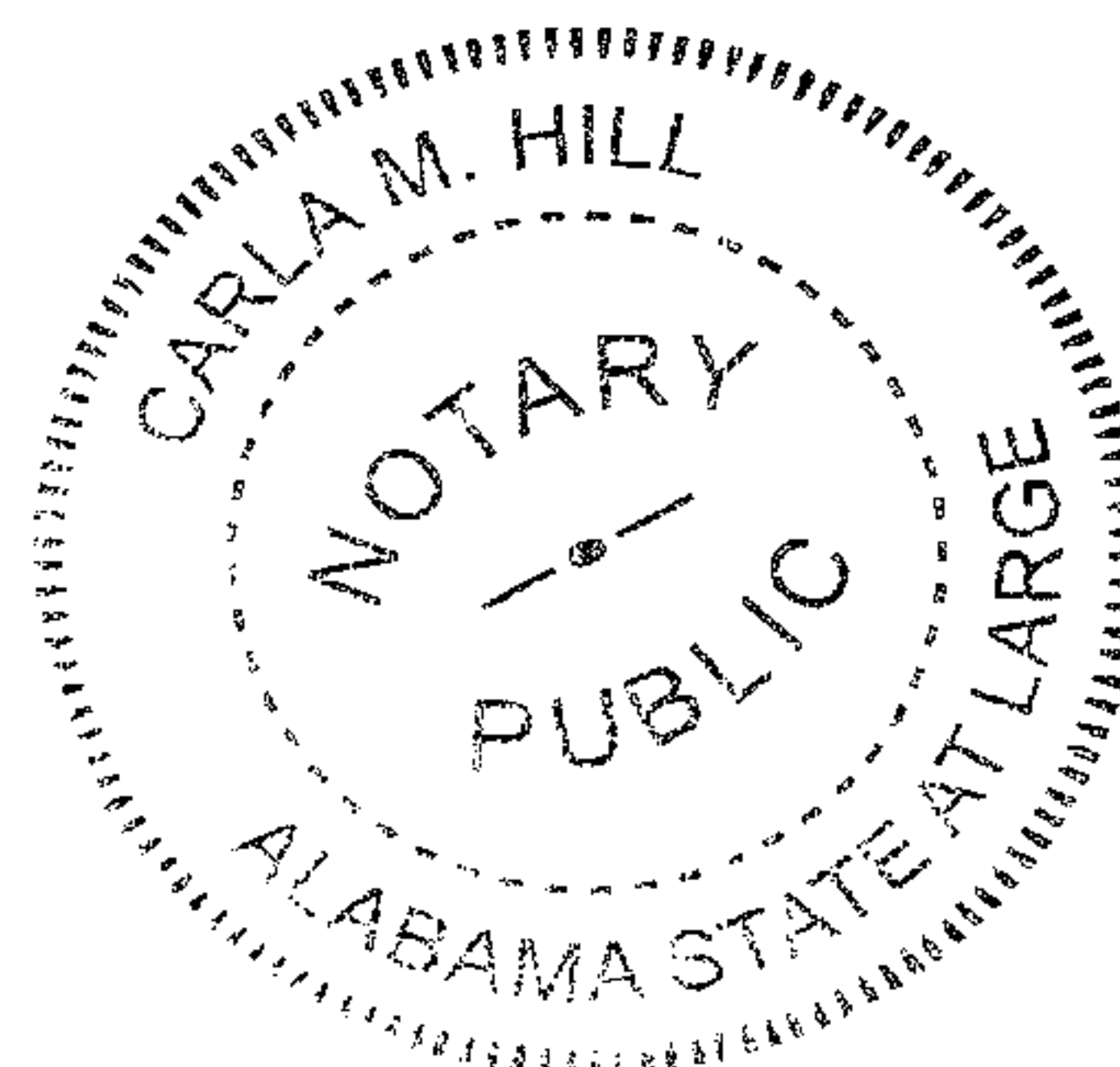
