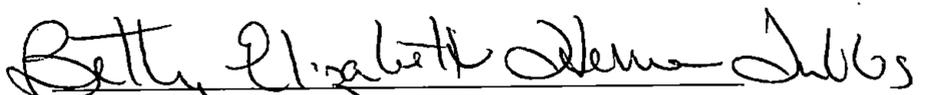
SUBJECT TO:

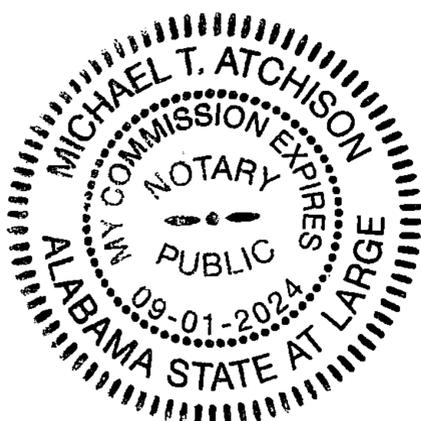

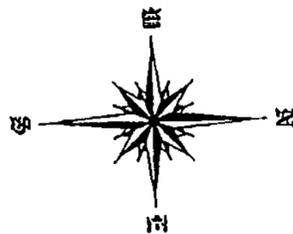
