
**An undivided ½ interest in and to the following described property:

TO HAVE AND TO HOLD to said **GRANTEE** forever.



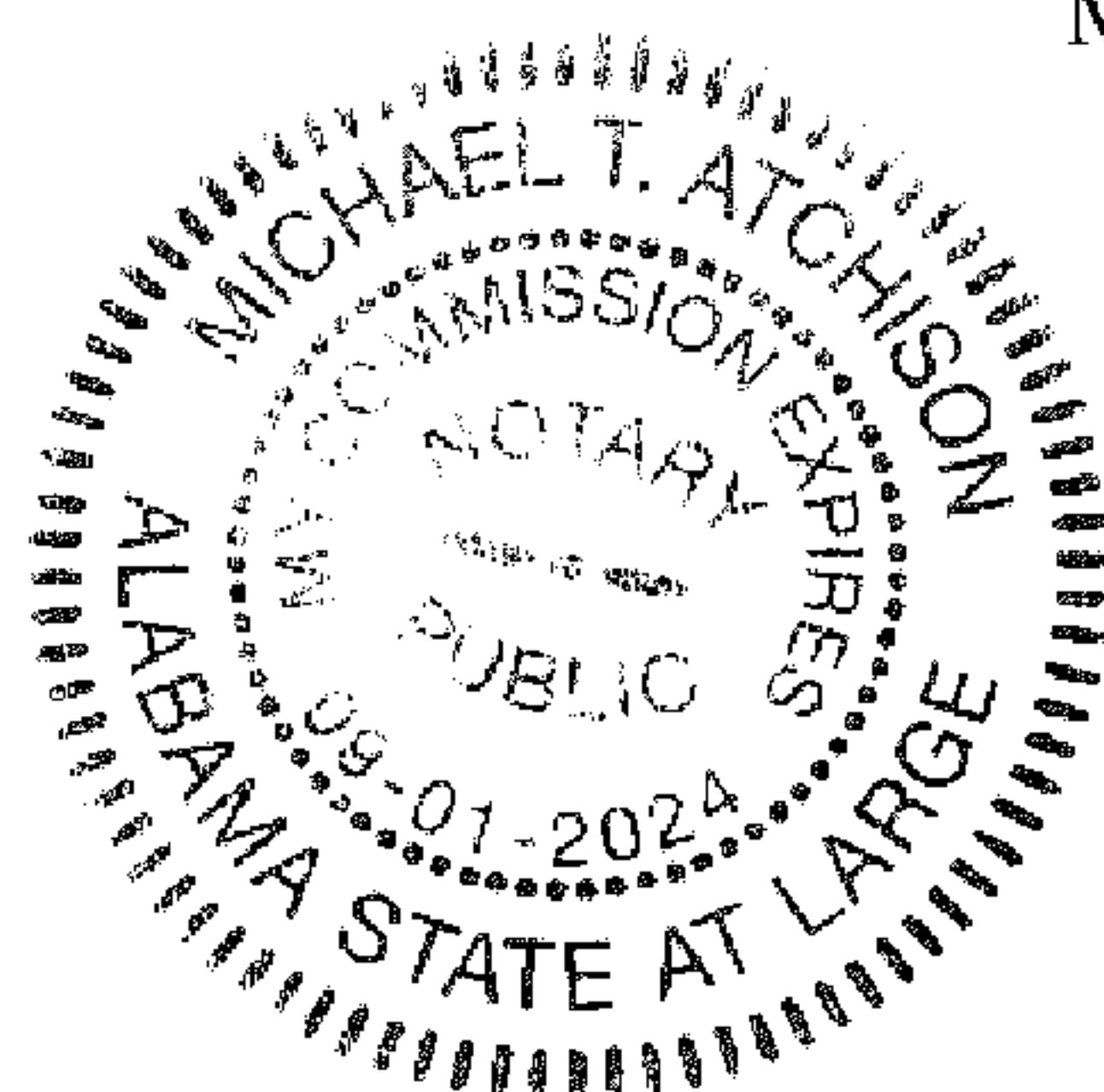
