

**AFFIDAVIT REGARDING CERTIFICATION OF TRUST
FOR THE R. KENT HATLEY TRUST AGREEMENT DATED AUGUST 20, 1992**

The undersigned, R. KENT HATLEY, being first duly sworn, deposes and says, he is at least 19 years of age and is the currently acting trustee of THE R. KENT HATLEY TRUST AGREEMENT DATED AUGUST 20, 1992, and further states the following:

THE R. KENT HATLEY TRUST AGREEMENT DATED AUGUST 20, 1992, is a valid, existing trust, having been created by R. KENT HATLEY.

- A. The original settlors of the trust are R. KENT HATLEY.
 - B. The following persons contributed money, funds, real property or personal property to the trust: R. KENT HATLEY
 - C. R. KENT HATLEY are alive and well.
- The name of the successor trustee is GEOFFREY K. HATLEY AND MATTHEW B. HATLEY.

THE R. KENT HATLEY TRUST AGREEMENT DATED AUGUST 20, 1992 has a definite beneficiary. The same person is not the sole trustee and sole beneficiary.

Excerpts from the trust agreement that establish the trust, designate the Trustee and set forth powers of the Trustee will be provided upon request. The administrative and/or managerial powers of the trustees are shown on the Powers of Trustee, and include the power to acquire, sell assign, convey, pledge, encumber, lease, borrow, manage and deal with real and personal property interests.

- A. The trust is revocable.
- B. The following trustee has the authority to sign documents and instruments: R. KENT HATLEY.
- C. R. KENT HATLEY can act alone and may exercise such powers by his signature.

The conditions for the succession of the successor trustees are vacancy.

The social security number assigned to the trust is the social security number R. KENT HATLEY.

Trust property should be titled as follows: R. KENT HATLEY, AS TRUSTEES OF THE R. KENT HATLEY TRUST AGREEMENT DATED AUGUST 20, 1992

To the best of the undersigned's knowledge, the trust has not been revoked, modified or amended in any manner that would cause the representations and statements contained herein to be incorrect.

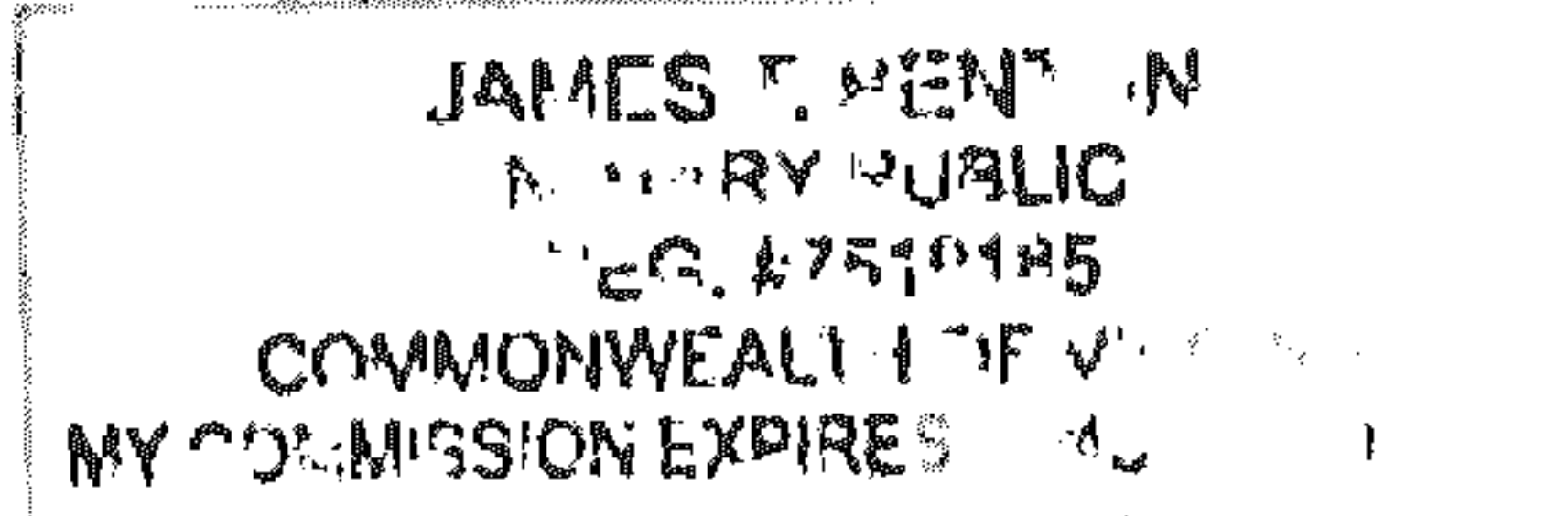

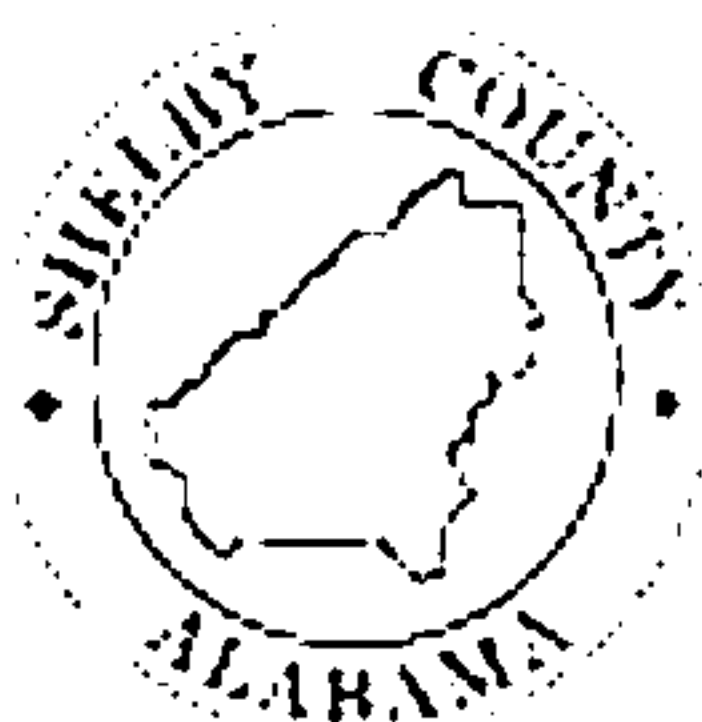
