THAT IN CONSIDERATION OF **Two Hundred Seventy-Five Thousand Dollars and NO/100 (\$275,000.00)** to the undersigned grantors, in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, **Marc Mauro and Holly H. Mauro, husband and wife**, (herein referred to as Grantors), grant, sell, bargain and convey unto, **Felix H. Chanchavac Vincente, who is also known as Heriberto Felix Chanchavac Vincente and Karla Y. Hernandez Herrera** (herein referred to as Grantees whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **Jefferson County, Alabama** to wit:




