I, GERALDINE ALICE WOODSON, a citizen of the United States of America, a resident of the County of Shelby, State of Alabama, being of sound and disposing mind and memory, do make, publish and declare this instrument as and for my Last Will and Testament, hereby revoking any and all other wills and codicils heretofore made by me.

ITEM I

PAYMENT OF DEBTS/PROBATE OF WILL

My Personal Representative shall first pay out of my estate all of my debts and expenses of administration, including the expenses of my last illness and funeral, as soon as possible after my death. I further direct that my Personal Representative may probate my Last Will and Testament either in the county of my residence at the time of my death or in any county in the State of Alabama in which I may own property at the time of my death.

ITEM II

DISPOSITION OF PERSONAL EFFECTS

(a) I may prepare a memorandum in conjunction with this Will which indicates my desires with regard to the disposition of special personal property of mine. If I prepare such memorandum, it will be an expression of my desires with regard to the disposition of such personal property. Although I realize that such memorandum shall not be binding upon the Personal Representative, I hope and expect that the Personal Representative and my beneficiaries will honor this expression of my desires.

(b) I give and devise all of my wearing apparel, jewelry, books, pictures, household furniture and furnishings, both useful and ornamental, any equity ownership interest in any club or organization of which I am a member, any vehicle that I may own, and all other objects of my personal use, and any cemetery plots, in substantially equal shares, to my nieces and nephews, Ernest Frank Woodson, Leisa Ann Woodson Stewart, Kevin Swanson Woodson, Wendell Martin Woodson, Richard Stanton Woodson, Holly Blair Woodson, Alison Rebecca Berger Patterson, Benjamin Woodson Berger and Blair Olivia Berger Richert (hereinafter such individuals shall be referred to as my "nieces and nephews"). If any said niece or nephew of mine should predecease me, then I give and devise such niece's or nephew's share of said property to his or her lineal descendants who survive me, if any, per stirpes, and if none, to such of my other said nieces and nephews, and the lineal descendants of any other deceased niece or nephew of mine who survive me, if any, per stirpes. In the event that my said nieces and nephews should all predecease me, leaving no lineal descendant of them surviving me, then this devise shall lapse, and the aforesaid property shall become a part of the residue of my estate. I hereby vest in my said Personal Representative, hereinafter named, full power and authority to determine what objects of property are included in the foregoing description contained in this Item of my Will, and to make such division of said objects of property among my beneficiaries as, in the opinion of my Personal Representative, may be desirable, having due regard for the personal preferences of my beneficiaries.

ITEM III

DEVISE OF CLARKE COUNTY REAL ESTATE

(a) I direct that my Personal Representative shall obtain a surveyor to survey the property that I own located in Clarke County, Alabama into three separate parcels. I request that these three parcels be as equal as possible by value; provided, however, to the extent possible, each parcel is intended to be a contiguous entity. After the property has been divided into three separate parcels, my Personal Representative shall follow the instructions set forth in paragraph (b) below and distribute one parcel to each of the following family groups:

(1) One parcel shall be distributed to Ernest Frank Woodson, Leisa Ann Woodson Stewart and Kevin Swanson Woodson, or the survivor(s) of them, per capita and not per stirpes.

(2) One parcel shall be distributed to Wendell Martin Woodson, Richard Stanton Woodson and Holly Blair Woodson, or the survivor(s) of them, per capita and not per stirpes.

(3) One parcel shall be distributed to Alison Rebecca Berger Patterson, Benjamin Woodson Berger and Blair Olivia Berger Richert, or the survivor(s) of them, per capita and not per stirpes.

(b) I direct that my Personal Representative have each parcel appraised by a qualified real estate appraiser. Each parcel shall then be assigned a number, and a representative of each of the three (3) family groups (as described above) will draw a number, which will correspond to the parcel to be distributed to each family group. Each family group will receive the parcel chosen by or for it, and my Personal Representative will issue a Statuary Warranty Deed to the members of each family group as tenants-in-common. Thereafter, if the family wants to divide the parcel, engage in sales among themselves, or otherwise handle the parcel, it is their decision.

(c) If there are any differences among the values of the parcels, then my Personal Representative shall transfer to each family group assets of my estate with a value equal to the difference (if any) between the value of their parcel and the most valuable parcel distributed.

ITEM IV

MONETARY DEVISE TO CHARITABLE INSTITUTION

(a) I give and devise the sum of Fifty Thousand and 00/100 Dollars (\$50,000.00) to The First United Methodist Church of Jackson, Alabama, located in Jackson, Alabama, if such institution shall be in existence at the time of my death. If such institution shall not be in existence at the time of my death, the devise to it shall lapse, and said property shall become a part of my residuary estate. In the event I have not designated the said beneficiary by its correct name, or if the said beneficiary is not incorporated, my Personal Representative is authorized to pay said devise to the governing body of the institution which,

in the Personal Representative's discretion, I have intended to designate as beneficiary of such devise, and the receipt of the officers of such institution shall be a complete discharge to the Personal Representative for such payment.

(b) I direct that all of my charitable gifts, bequests, and devises shall be made, to the extent possible, from property that constitutes "income in respect of a decedent" as that term is defined in the Internal Revenue Code.

ITEM V

DISPOSITION OF RESIDUE

(a) All the rest, residue and remainder of the property which I may own at the time of my death, whether real, personal and mixed, tangible and intangible, of whatsoever nature and wheresoever situated, including all property which I may acquire or become entitled to after the execution of this Will, including all lapsed legacies and devises and including any property over or concerning which I may have any power of appointment (my "Residuary Estate"), I devise in fee and in equal shares to my nieces and nephews, Ernest Frank Woodson, Leisa Ann Woodson Stewart, Kevin Swanson Woodson, Wendell Martin Woodson, Richard Stanton Woodson, Holly Blair Woodson, Alison Rebecca Berger Patterson, Benjamin Woodson Berger and Blair Olivia Berger Richert. If any of my nieces or nephews should predecease me, then I give and devise such niece's or nephew's share of said property to his or her lineal descendants who survive me, if any, per stirpes, and if a niece or nephew should predecease me leaving no lineal descendants, the share of such deceased niece or nephew shall be distributed in equal shares to the siblings of such deceased niece or nephew, who survive me, per stirpes; provided, that if any of my nieces and nephews or any lineal descendant of a deceased niece or nephew shall then have other property held in trust for him or her under a trust created by one or both of his or her parents that is in existence at the time of my death, or created within three (3) months after my death, then his or her share shall be distributed to the Trustee then serving of such trust and disposed of like such other property so held in trust for him or her.

(b) If there shall be no niece or nephew of mine and no lineal descendant of a deceased niece or nephew who survives me, then my Residuary Estate shall be distributed to The First United Methodist Church of Jackson, Alabama, located in Jackson, Alabama. This amount is to be designated in memory of Ernest and Elwyn Woodson. In the event said charitable beneficiary is not designated by its correct name, or if said beneficiary is not incorporated, or if such charitable organization is not in existence, my Personal Representative is authorized to distribute such property to the governing body of the charitable organization which, in my Personal Representative's discretion, is intended as beneficiary of such distribution, and the receipt of the officers of such charitable organization shall be a complete discharge to my Personal Representative for such payment. In the event that the charitable organization named or referred to herein does not qualify as organizations described in I.R.C. Sections 170(c), 2055 and 2522, at the time when any amount is to be irrevocably transferred to such organization, then my Personal Representative shall transfer such amount or amounts to such other organization or organizations as shall then be described in and qualify under such sections as my Personal Representative, in its sole discretion, shall determine is consistent with my charitable motivations.

ITEM VI

DIRECTIONS REGARDING BENEFICIARIES

UNDER THE AGE OF TWENTY-FIVE OR WITH A DISABILITY

(a) Except as otherwise provided in paragraph (a) of Item IV or paragraph (b) below, if any of my beneficiaries shall be under the age of twenty-five (25) years at my death, then I direct that my Personal Representative, in its sole discretion, shall either: (1) transfer and pay over the share of such beneficiary to itself, as Trustee, to hold such property in trust for said beneficiary until he or she shall attain the age of twenty-five (25) years, using and applying for such beneficiary's support, education and comfort, such part of the net income or principal, or both, from his or her share of the trust as the Trustee deems necessary or desirable for said purpose, with any income not so paid or applied to be accumulated and added to the principal of his or her share of the trust estate at the end of each fiscal year of the trust; (2) if the

beneficiary has not attained the age twenty-one (21) years, pay over said property to any custodial account that has already been established for the beneficiary, or if none exists, to a custodian designated by the Personal Representative from those persons, including the Personal Representative, who are eligible to serve as such custodian of the beneficiary under the Uniform Transfers (or Gifts) to Minors Act in effect in the state of the beneficiary's residence, for the use and benefit of the beneficiary; or (3) if the beneficiary has attained the age twenty-one (21) years and the Personal Representative determines that the beneficiary is able to handle all of his or her share at such age, then pay over said property to such beneficiary. In all events, the share of any such beneficiary shall be deemed then to have vested in him or her, and shall be payable to his or her estate in the event of his or her death prior to attaining the age of twenty-five (25) years. If the trust option is chosen, I hereby vest in my Personal Representative as Trustee the same full powers of management and control over the principal of said trust and accumulated income, if any, herein given to the Personal Representative over my estate under any paragraph hereof, and I direct that said Trustee shall not be required to give any bond or security for the performance of its duties as such Trustee. Upon making any such payment hereunder, the Personal Representative shall be discharged as to any sums so paid.

(b) Where I have herein directed that funds shall be used and applied by the Personal Representative for the benefit of or paid to any beneficiary with a disability, regardless of age, who is receiving public assistance benefits because of such disability at the time of distribution, or, in the discretion of the Personal Representative, will likely become eligible in the future for public assistance benefits, then, instead of any other provision herein for the distribution of such beneficiary's share, the terms of this paragraph (b) shall control. The Personal Representative shall either (i) pay over such beneficiary's share to the Trustee of an existing third-party special needs trust for the benefit of such beneficiary, or (ii) establish a third-party special needs trust for such beneficiary to receive such share (including without limitation a private trust or a pooled trust account such as the Alabama Family Trust), or (iii) may contribute such funds to an ABLE Act account for such beneficiary, or (iv) may apply such funds for services or exempt resources for such beneficiary. Any special needs trust selected by my Personal Representative to

receive such share (whether then existing or established by my Personal Representative as a private trust or an Alabama Family Trust or other pooled trust) must be established for the benefit of such beneficiary, with income and principal to be applied for such beneficiary during his or her lifetime, in the complete discretion of the Trustee taking into account other resources and public assistance benefits available to such beneficiary, with any remaining funds in such trust or pooled trust account upon such beneficiary's death to be distributed in the same manner and to such beneficiaries as would have received such beneficiary's share hereunder if he or she had predeceased me.

(c) The Personal Representative shall make such distribution decisions under this Item in its sole discretion. The receipt of the distributee under any of these methods of distribution shall be full discharge to the Personal Representative serving hereunder as to any sums so paid.

ITEM VII

PERSONAL REPRESENTATIVES

(a) I hereby nominate and appoint Leisa Ann Woodson Stewart and Holly Blair Woodson as Personal Representative of this, my Last Will and Testament. In the event Leisa Ann Woodson Stewart shall predecease me or shall die during the administration of my estate or be unable or unwilling to serve as Personal Representative, then I nominate and appoint Ernest Frank Woodson to serve in her place and stead as Personal Representative. In the event Holly Blair Woodson shall predecease me or shall die during the administration of my estate or be unable or unwilling to serve as Personal Representative, then I nominate and appoint Richard Stanton Woodson to serve in her place and stead as Personal Representative. In the event all of Leisa Ann Woodson Stewart, Holly Blair Woodson, Ernest Frank Woodson and Richard Stanton Woodson shall predecease me or shall die during the administration of my estate or be unable or unwilling to serve as Personal Representative, then I nominate and appoint Alison Rebecca Berger Patterson to serve as Personal Representative.

(b) It is my will and desire that my Personal Representative, regardless of who shall so serve, shall not be required to give any bond or security for the performance of its duties as such Personal

Representative or to account to any court for its acts and doings as such Personal Representative, and that it is hereby expressly exempted from filing any inventory or making any report or final settlement of my estate. Said Personal Representative shall have full power, without the necessity for any order from any court, to sell (for payment of debts and all other purposes), exchange, lease, or encumber all or any portion of my estate in such manner and upon such terms and conditions as it may approve; to invest and reinvest my estate and the proceeds of sale of any portion thereof in such loans, stocks, bonds or other securities, mortgages, common trust funds, or other property as it may consider suitable, whether or not a so-called "legal" investment of trust funds, and to change investments and to make new investments from time to time as to it may seem necessary or desirable; to make divisions and distributions hereunder provided for either in cash or in kind or partly in cash and partly in kind, and for that purpose to determine the values thereof, and to determine the identity of persons entitled to take hereunder; to institute and defend any and all suits or legal proceedings relating to my estate, in any court, and to employ counsel and to compromise or submit to arbitration all matters of dispute in which my estate may be involved, as in its judgment may be necessary or proper. Said Personal Representative shall also have full power and authority, without the necessity for any order from any court, to pay the expenses of administering my estate, including the payment of compensation to my Personal Representative, at such time or times as my Personal Representative deems appropriate. Said Personal Representative shall also have full power and authority to continue to operate, carry on, repair, renew, insure, and otherwise conserve and maintain any business or business item or asset of my estate, and to enter into and perform any contracts necessary and desirable in connection therewith, and shall have full power and authority to borrow money on account of my estate and secure same by mortgage or pledge of any asset thereof, all without the necessity for any other order from any court or notice to anyone whatsoever. It is also my direction and intention that my Last Will and Testament be interpreted and administered by my Personal Representative in accordance with the Internal Revenue Code. My Personal Representative shall have the sole and absolute discretion to exercise any rights of election suitable under or in respect to any tax law, and shall not be liable to any beneficiary herein for any action taken or not taken, election made or not made, or resulting federal income tax consequences

thereof or from the apportionment or distribution in kind or otherwise of any asset of my estate, where such Personal Representative has exercised good faith and ordinary diligence in the performance of its duties.

(c) Should it be necessary for a representative of my estate to qualify in any jurisdiction wherein the Personal Representative named herein is not qualified as such, then my Personal Representative named herein shall, without giving any security, qualify and act as Personal Representative in such jurisdiction and shall have therein all rights, powers, authorities, duties and discretions conferred or implied upon the Personal Representative by this Will, or if such Personal Representative cannot or does not desire to qualify in such other jurisdiction, or if at any time and for any reason there shall be no Personal Representative in office in such other jurisdiction, then I appoint as Personal Representative therein such person or corporation as may be designated by my Personal Representative. Such substituted Personal Representative shall, without giving any security, have in such other jurisdiction all the rights, powers, authorities, duties and discretions conferred or imposed upon the Personal Representative by the provisions of this Will.

(d) Any individual acting or named to act as Personal Representative hereunder or required to be competent in order to act hereunder shall be deemed to be incompetent to act when a licensed physician or neuropsychologist whom such individual has consulted within the prior three years has certified as to such consultation and also as to the present lack of the physical or mental capacity of such individual to manage his or her financial affairs.

(e) It is my desire to permit a settlement of my estate and any trust created under my Will by consent which shall be effective with respect to each beneficiary of my estate and any such trust (notwithstanding the Personal Representative and Trustee may be the same or that a beneficiary who is incompetent or incapacitated may be entitled to receive property hereunder), by taking advantage of the provisions allowing settlement by consent without notice pursuant to Section 43-2-506 of the Code of Alabama, as amended. Accordingly, I do hereby authorize the (i) parent, guardian, conservator, custodian, or Agent acting under a valid Power of Attorney, of any unborn or incapacitated or incompetent beneficiary, (ii) Trustee of any trust created under my Will, or (iii) Personal Representative or beneficiaries/heirs of any

ITEM VIII

PROVISIONS FOR MULTIPLE FIDUCIARIES

While two or more fiduciaries are acting, the following provisions shall apply where the context permits:

(a) With respect to any matter as to which the fiduciaries have joint authority, a fiduciary from time to time may delegate any or all of that fiduciary's rights, powers, duties, and discretion as fiduciary to the other fiduciary(ies), with the consent of the latter;

(b) The fiduciaries may establish bank accounts and may authorize that checks or drafts may be drawn on, or withdrawal made from, any such account on the individual signature of any one fiduciary;

(c) A fiduciary shall be presumed to have approved a proposed act or decision to refrain from acting if that fiduciary fails to indicate approval or disapproval thereof within fifteen (15) days after a written request for approval; and

(d) The fiduciaries may execute documents by jointly signing one document or separately signing concurrent counterpart documents.
