WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of TWO HUNDRED SIXTY FIVE THOUSAND AND 00/100 (\$265,000.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Cecilia Nicole Vernon, a married woman** (hereinafter referred to as GRANTOR whether one or more), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEE, **Rafael Valencia and Elvira Valencia, Husband and Wife** (hereinafter referred to as GRANTEE whether one or more), in fee simple, together as joint tenants with rights of survivorship, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Commencing at a 2" crimped iron found at the NE corner of the SE 1/4 of the NE 1/4 of Section 12, Township 21 South, Range 3 West, Shelby County, Alabama, being the POINT OF BEGINNING; thence N 89°02'59" W along the north line of said 1/4-1/4 for 1145.00' to a 5/8" rebar (Gilbert 17507) set; thence S 1°27'04" E 90.46' to a 5/8" rebar (Gilbert 17507) set; thence along the easterly right of way of Wooten Road S 40°56'03" E 57.82' to the point of curvature of a curve to the right having a radius of 305.52' a central angle of 39°32'06", and a chord of 206.66' bearing S 21°09'34" E; thence Southeast along said curve 210.81' to a 5/8" (Gilbert 17507) set; thence S 1°23'52" E 55.80' to a 5/8" rebar (Gilbert 17507) set; thence leaving said right of way S 89°05'51" E 1035.66' to a 5/8" rebar (Gilbert 17507) set; thence N 1°01'44" W 380.00 along the east line of said 1/4-1/4 for to the POINT OF BEGINNING, said described tract containing 9.46 Acres, more or less.
