(herein referred to as grantees) as joint tenants with right of survivorship, the following described real estate property situated in Shelby County, Alabama, the address of which is: 128 Creden Pl., Alabaster, AL 35007 to-wit:

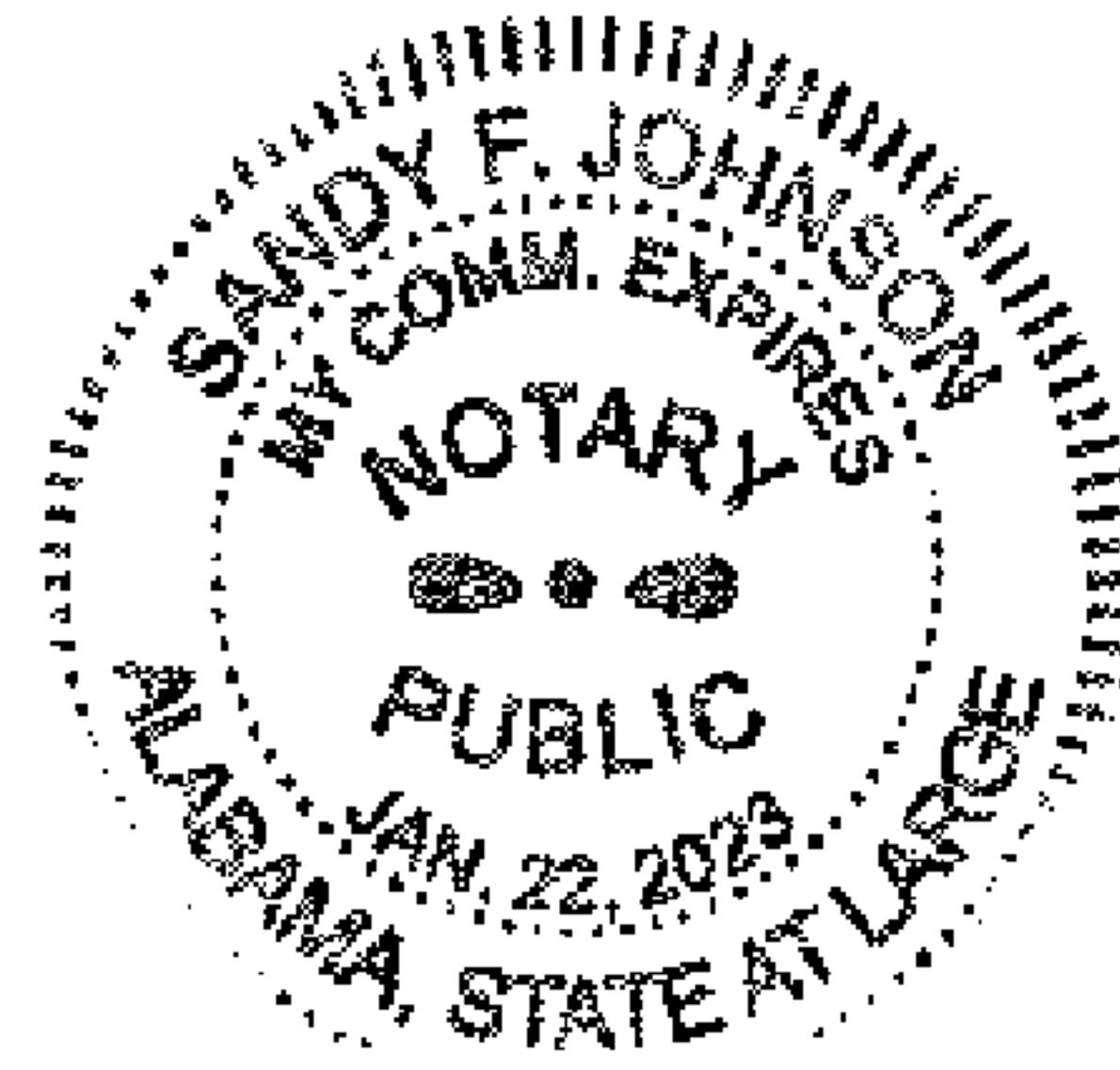
