

HEIRSHIP AFFIDAVIT

Sally Trenholm a/k/a Sally Mae Trenholm, a widow, during her lifetime was the owner or had ownership interest in the following described tracts of land, situated in Shelby County, Alabama, to wit:

FIRST: Conveyed from Henry Williams and wife, Sarah Williams to Horace Trenholm and wife, Sally Trenholm August 24, 1970, and recorded August 24, 1970, at Bk: 263 Pg: 582, with the Judge of Probate for Shelby County, Alabama.

That certain lot or parcel of land situated in the South Half of the SE ¼ of the SW ¼ of Section 36, Township 20, Range 3 West, described as follows: Commencing at an iron stake on the Southeast side of Harpersville dirt road (now a black top road); run parallel with said road right of way 570 feet; thence South 210 feet parallel with the East line of Walter Motley lot to the point of beginning of land herein described and conveyed; run thence South 420 feet; run thence West 420 feet; run thence North 420 feet; run thence East 420 feet to the point of beginning. From the Northwest corner of the South half of the SE ¼ of the SW ¼ of section 36, Township 20 South, Range 3 West, run easterly along the north boundary line of the said South ½ of the SE ¼ of the SW ¼ of Section 36, Township 20 South, Range 3 West, for 360.0 feet, thence turn an angle of 88 degrees 34 minutes 45 seconds to the right and run southerly 210.0 feet, thence turn an angle of 88 degrees 34 minutes 45 seconds to the left and run easterly 177.05 feet to the point of beginning of the land herein described; thence continue easterly along the last course for 210.0 feet; thence turn an angle of 102 degrees 18 ½ minutes to the right and run southwesterly 210.0 feet; thence turn an angle of 77 degrees 41 ½ minutes to the right and run westerly 210.0 feet; thence turn an angle of 102

THIRD: Conveyed from Horace Freeman Trenholm to Horace Freeman Trenholm and wife, Sally Mae Trenholm on May 23, 2002, and recorded May 23, 2002 at Instrument No.: 20020523000245410, with the Judge of Probate for Shelby County, Alabama.

From the Southeast corner of the SE ¼ of the SW ¼ of Section 1, Township 21 South, Range 3 West, run Northerly along the East boundary line of the said SE ¼ of the SW ¼ of Section 1, Township 21 South, Range 3 West, for 454.24 feet; thence turn an angle of 87 degrees, 18 minutes to the left and run Westerly for 42.33 feet to the point of beginning of the land herein described and conveyed; thence continue Westerly for 215.0 feet to a point of the Ala. State highway Department Right of Way line; thence turn an angle of 67 degrees, 00 minutes to the right and run Northwesterly along the A.S.H.D. R.O.W. line for 30.00 feet; thence turn an angle of 82 degrees, 22 minutes to the right and run Northeasterly for 134.60 feet; thence turn an angle of 52 degrees, 00 minutes to the left and run Northeasterly for 88.94 feet; thence turn an angle of 144 degrees, 33 minutes to the right and run Southeasterly for 210.0 feet, more or less, to the point of beginning.
