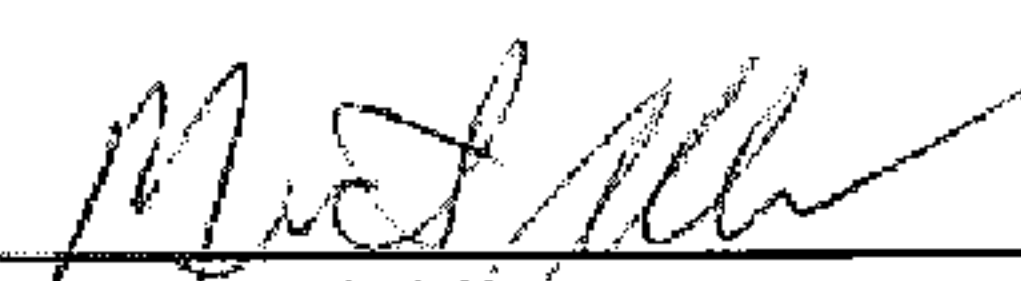
Property constitutes no part of the homestead of the Grantor herein or his spouse.

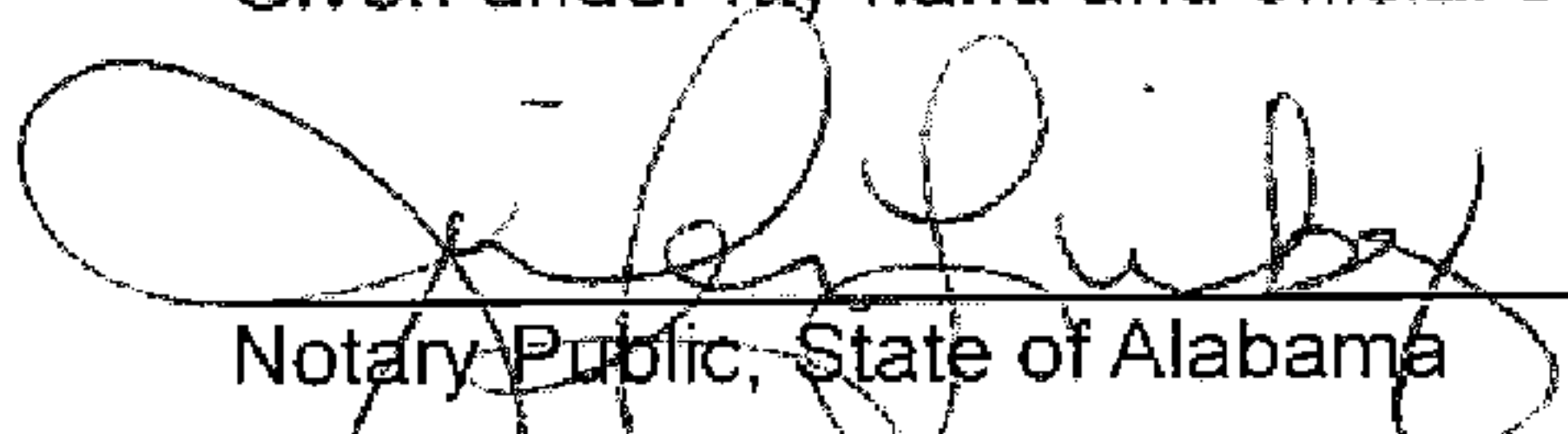

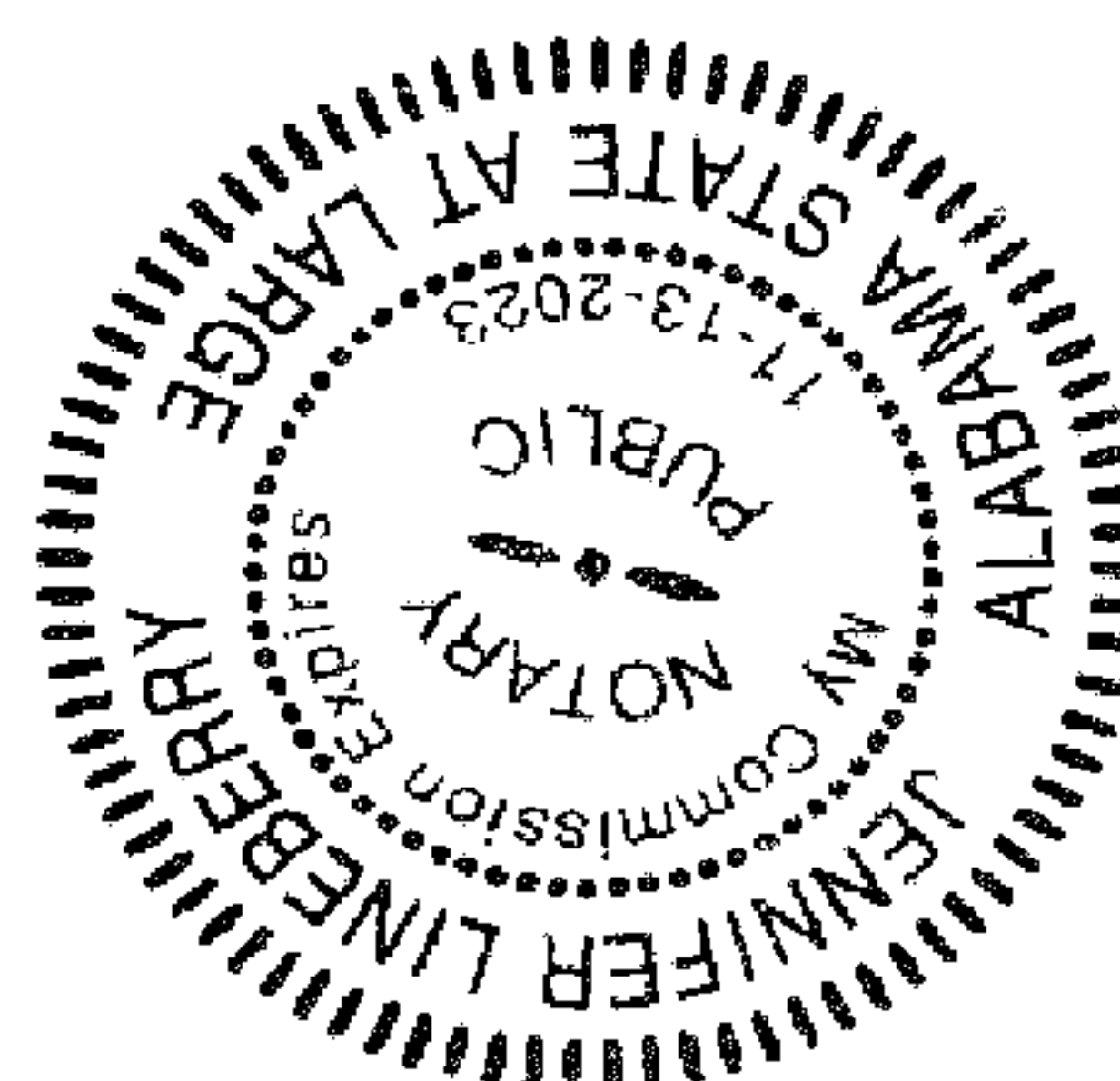
