All references in any of the Loan Documents to any of the other Loan Documents shall refer to such other Loan Documents as amended and modified hereby and as same may be further amended, modified, extended or restated from time to time. Each of the Security Documents shall from and after the Effective Date hereof secure, inter alia, the payment of the debts, liabilities and obligations of Borrower under the HELOC, as amended, modified, extended and restated, as the same may be further amended, modified, extended, and restated from time to time.
