FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, December 10, 2018, John L. Baker, a single man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems Inc., as nominee for Loandepot.com, LLC, which said mortgage was recorded in Instrument Number 20181217000439060 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage subsequently transferred and assigned to loanDepot.com, LLC by instrument recorded in Instrument Number 20200601000216680 in the aforesaid Probate Office Transferee and

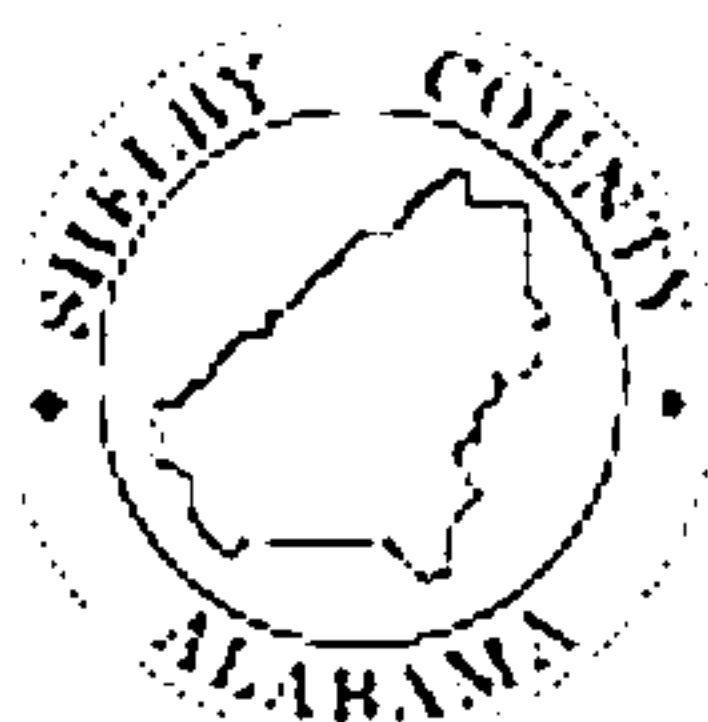
