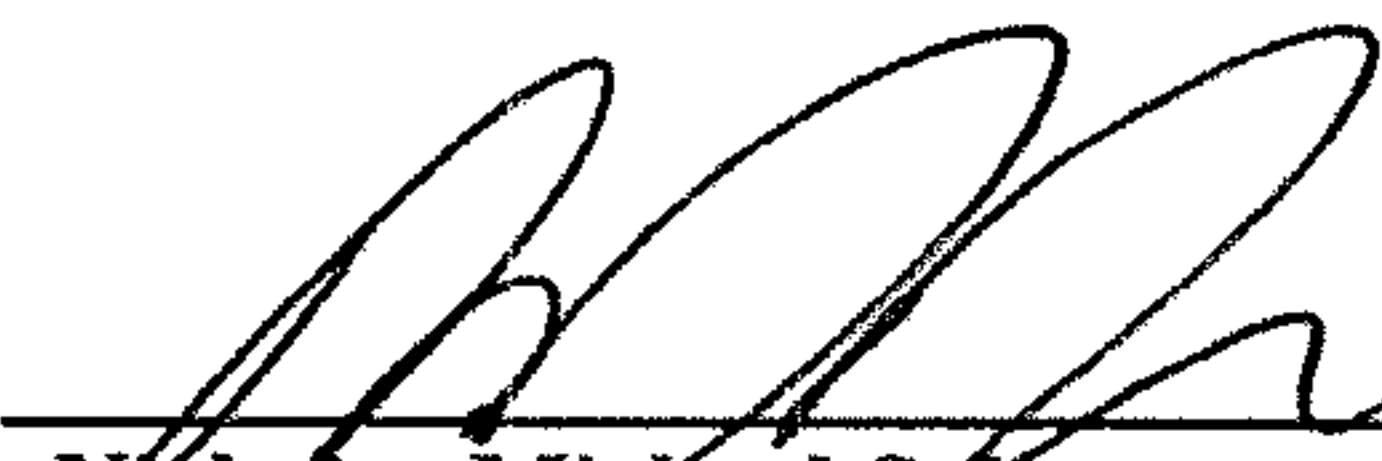
Mineral and mining rights excepted. Subject to: current taxes, easements, covenants, conditions and restrictions of record.

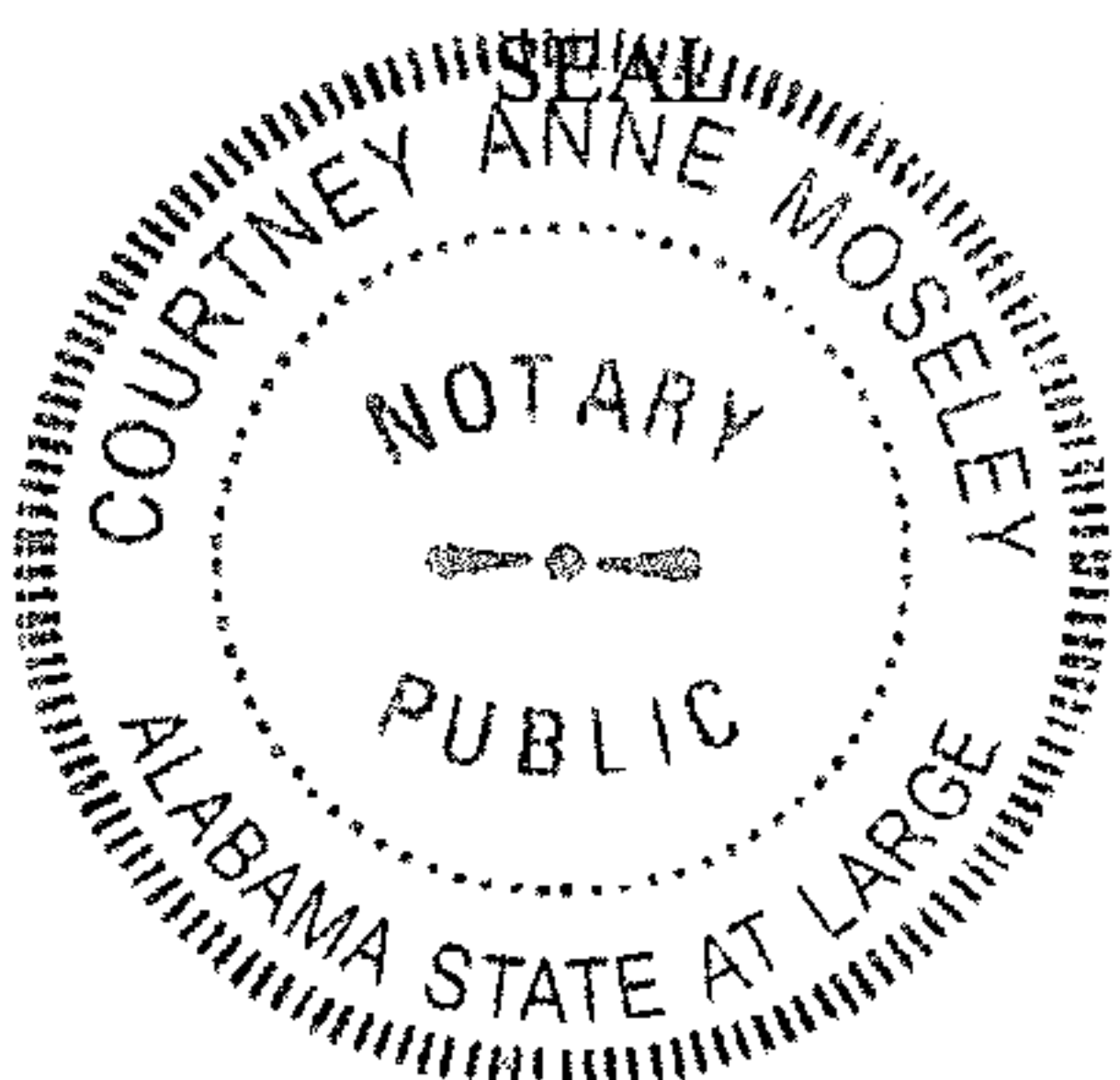


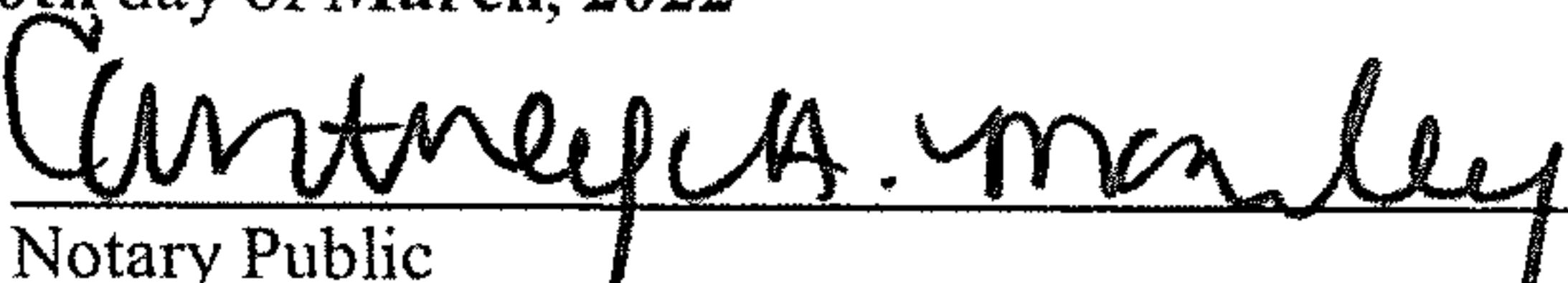

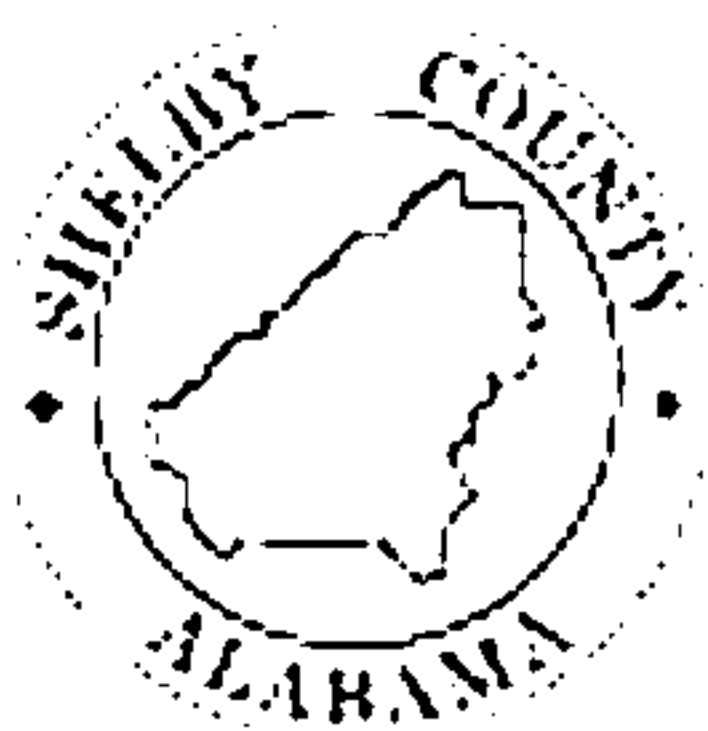
