- 5. The trust is revocable and may be revoked by the settlors.
- 6. The trust does have multiple trustees. The signature of one of the trustees is required to exercise the powers of the trust.

8. Title to trust assets should be taken in the following fashion:

PHILLIP ALLEN THOMAS and ANN McKEEL THOMAS, Trustees of the PHILLIP ALLEN THOMAS and ANN MCKEEL THOMAS REVOCABLE LIVING TRUST dated 120, and any amendments thereto.

For titling purposes, any description referring to the trust is effective if it includes the name of the trust, the name of at least one trustee, and any reference indicating property is being held by the trustee in a fiduciary capacity.

- 9. The undersigned trustees declare that the trust has not been revoked, modified, or amended in any manner which would cause the representations contained in this certification to be incorrect.
- 10. Pursuant to the provisions of Alabama Code § 19-3B-1013(b), a certification of trust may be signed or otherwise authenticated by any trustee.
- 11. Pursuant to the provisions of Alabama Code § 19-3B-1013(d), a certification of trust need not contain the dispositive terms of the trust.
- 12. Pursuant to the provisions of Alabama Code § 19-3B-1013(e), a recipient of a certification of trust may require the trustee to furnish copies of those excerpts from the original trust instrument and later amendments which designate the trustee and confer upon the trustee the power to act in the pending transaction.
- 13. Pursuant to the provisions of Alabama Code § 19-3B-1013(f), a person who acts in reliance on a certification of trust without knowledge that the representations contained in the certification are incorrect is not liable to any person for so acting and may assume without inquiry the existence of the facts contained in the certification.
- 14. Pursuant to the provisions of Alabama Code § 19-3B-1013(g), a person who in good faith enters into a transaction in reliance on a certification of trust may enforce the transaction against the trust property as if the representations contained in the certification were correct.
- 15. Pursuant to the provisions of Alabama Code § 19-3B-1013(h), a person making a demand for the trust instrument, in addition to a certification of trust or excerpts, shall be liable for damages if the court determines that the person did not act in good faith in demanding the trust instrument.
