**WARRANTY DEED**

**KNOW ALL MEN BY THESE PRESENTS,**

**On this March 31, 2022,** That for and in consideration of **ONE HUNDRED SIXTY FIVE THOUSAND AND NO/100 (\$165,000.00) DOLLARS,** and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS **FELIX K. DUNN, an unmarried person,** (herein referred to as "Grantor"), in hand paid by the Grantee herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the GRANTEE, **ROBERT C. GREENE,** (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA,** to wit:

A part of the NW ¼ of the NW ¼ of Section 16, Township 19 South, Range 2 East, and the NE ¼ of the NE ¼ of Section 17, Township 19 South, range 2 East, described as follows:

Begin at the NE corner of the NE ¼ of the NE ¼ of Section 17, Township 19 South, Range 2 East; thence run West along the North line thereof for 320.97 feet to an iron; thence 88 deg. 11 min. left run South for 319.00 feet; thence 90 deg. 35 min. left run 322.79 feet to the West line of the NW ¼ of the NW ¼ of Section 16, Township 19 South, Range 2 East; thence continue last described course for 218.21 feet; thence 89 deg. 19 min. 30 sec. left run North for 310.79 feet to the Southerly Right of Way of Shelby County Highway #83; thence 81 deg. 51 min. 10 sec. left run Northwesterly along said Right of Way for 50.0 feet to the North line of last said Section; thence 6 deg. 19 min. 42 sec. left run 171.27 feet to the point of beginning; being situated in Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2022 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantor.
4. Any applicable zoning ordinances.

**AND SAID GRANTORS**, for said GRANTOR, GRANTOR'S heirs, successors, executors and administrators, covenants with GRANTEE, and with GRANTEE'S heirs and assigns, that GRANTOR is lawfully seized in fee simple of the said Real Estate; that said Real Estate is free and clear from all liens and encumbrances, except as hereinabove set forth, and except for taxes due for the current and subsequent years, and except for any restrictions pertaining to the Real Estate of record in the Probate Office of **SHELBY COUNTY**; and that GRANTOR will, and GRANTOR'S heirs, executors and administrators shall, warrant and defend the same to said GRANTEE, and GRANTEE'S heirs and assigns, forever against the lawful claims of all persons.

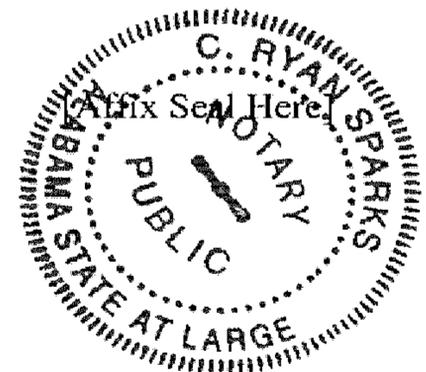
