That in consideration of the sum of **One Hundred Twenty Five Thousand Dollars and No Cents (\$125,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Gary E. Coshatt, a married man and Dennis C. Coshatt, a married man** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Joseph Zupanick and Lei Shi**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama; to wit;

All of that portion of the Southeast 1/4 of the Northwest 1/4 of Section 10, Township 22 South, Range 4 West, Shelby County, Alabama, which lies North and West of Highway #54. Situated in Shelby County, Alabama.

\$100,000.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.



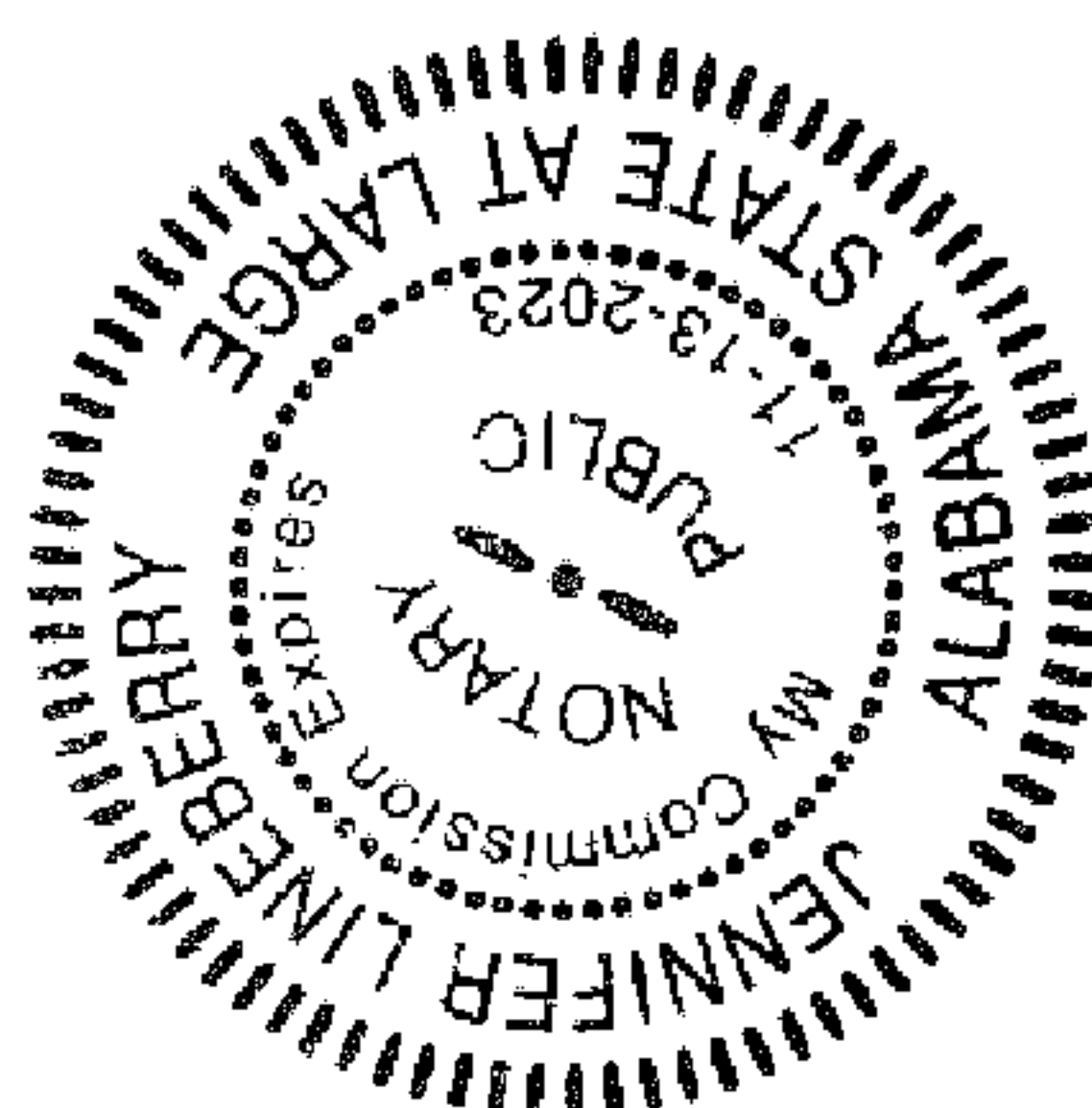
