Know All Men by These Presents: That in consideration of **Four Hundred Seventy-Four Thousand Nine Hundred and no/100 Dollars (\$474,900.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **DONOVAN BUILDERS, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **CHARLES A. BALLARD and LAUREN G. BALLARD** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

Lot 609, according to the Final Plat of Grey Oaks Subdivision, Phase 6, as recorded in Map Book 53, Page 78 A and B, in the Probate Office of Shelby County, Alabama.

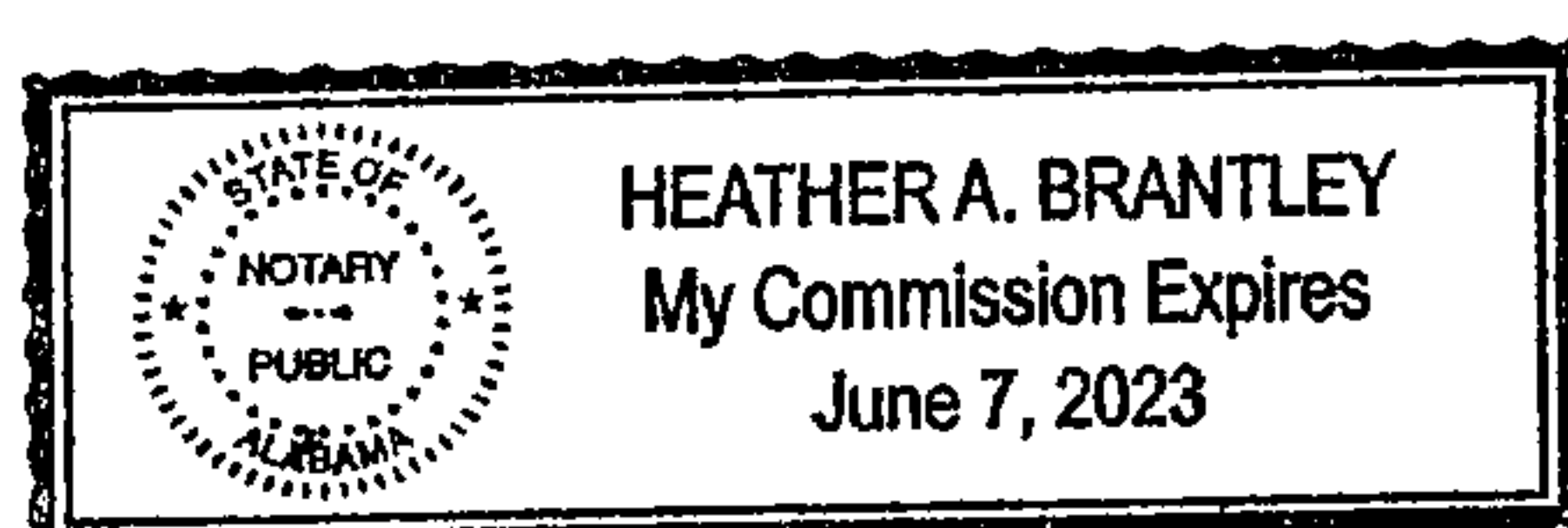

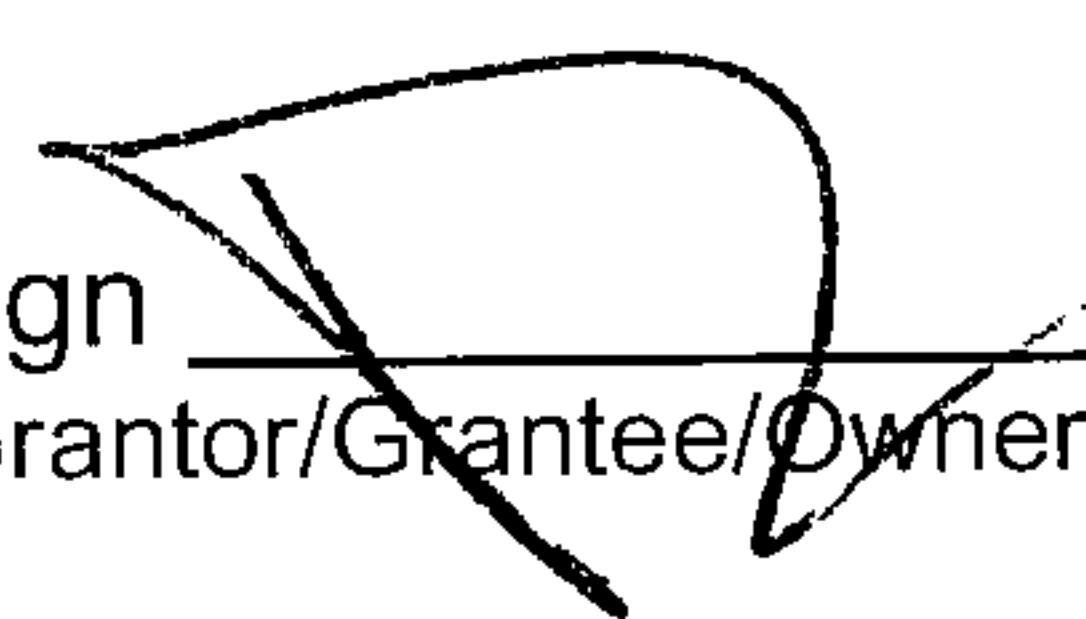
