
Property constitutes no part of the homestead of the Grantors herein or their spouses.


\$117,826.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.



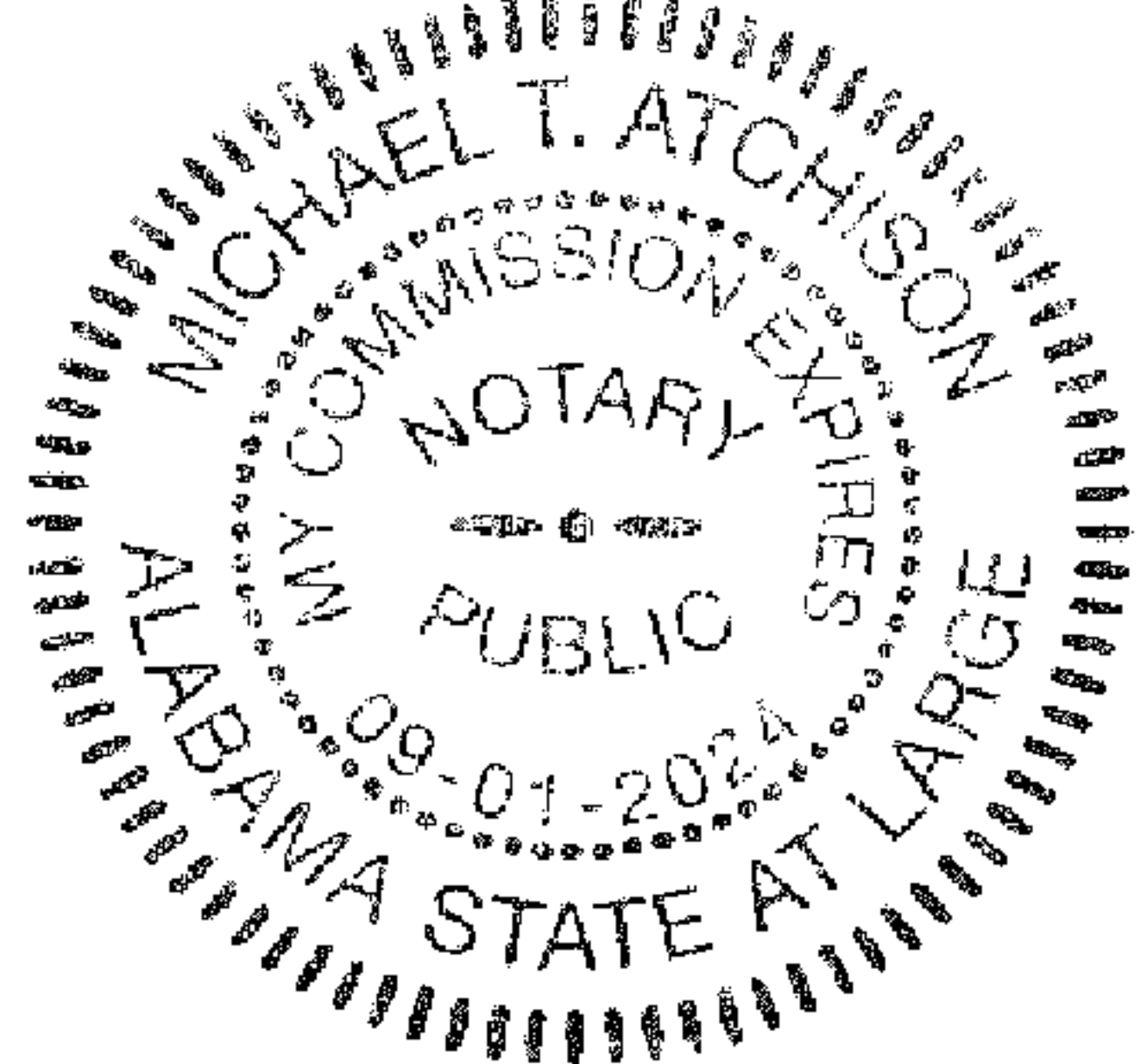
