KNOW ALL MEN BY THESE PRESENTS, That in consideration of **TEN THOUSAND DOLLARS AND NO CENTS (\$10,000.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, we, ***Daniel Howard Holcombe and Kori McNeill Holcombe, husband and wife (herein referred to as Grantors)*** grant, bargain, sell and convey unto ***Torie Rinehart Nix and Ricky Lee Nix (herein referred to as Grantees)***, the following described real estate, situated in: **SHELBY** County, Alabama, to-wit:

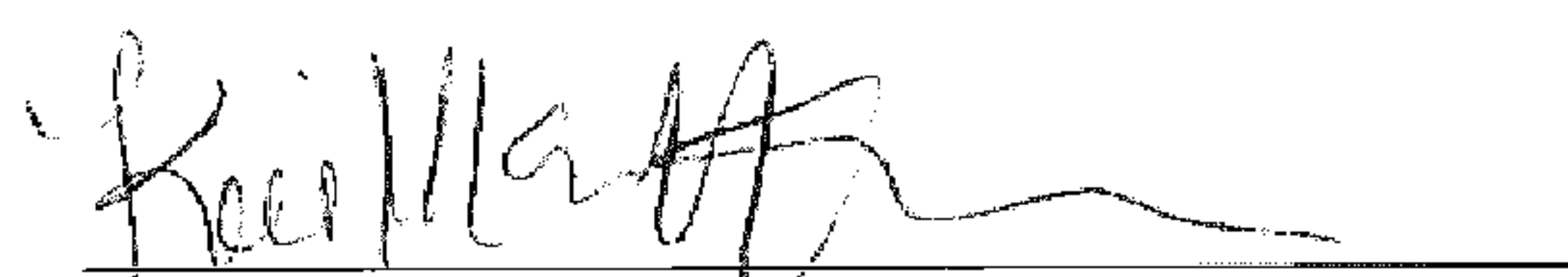

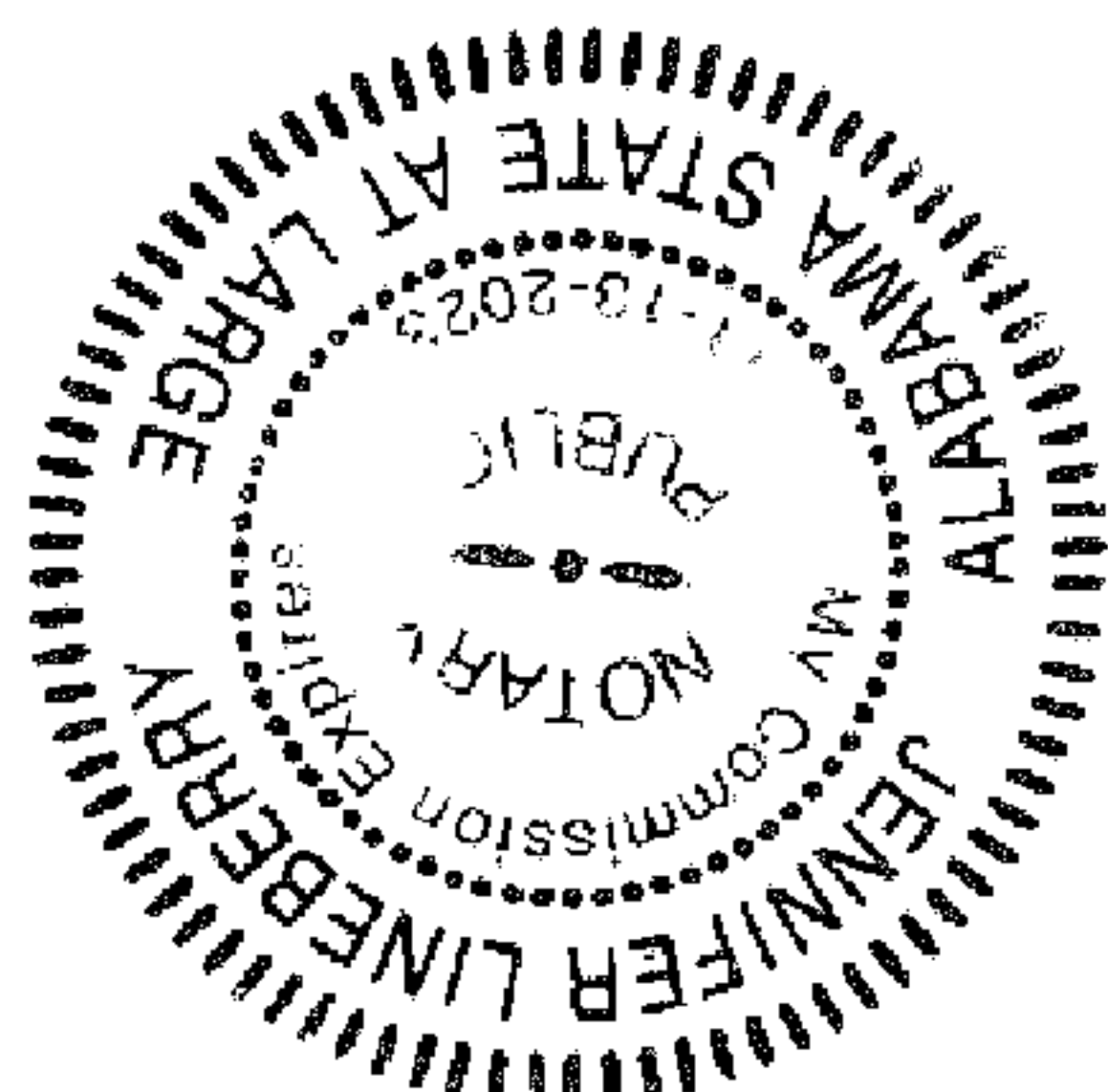

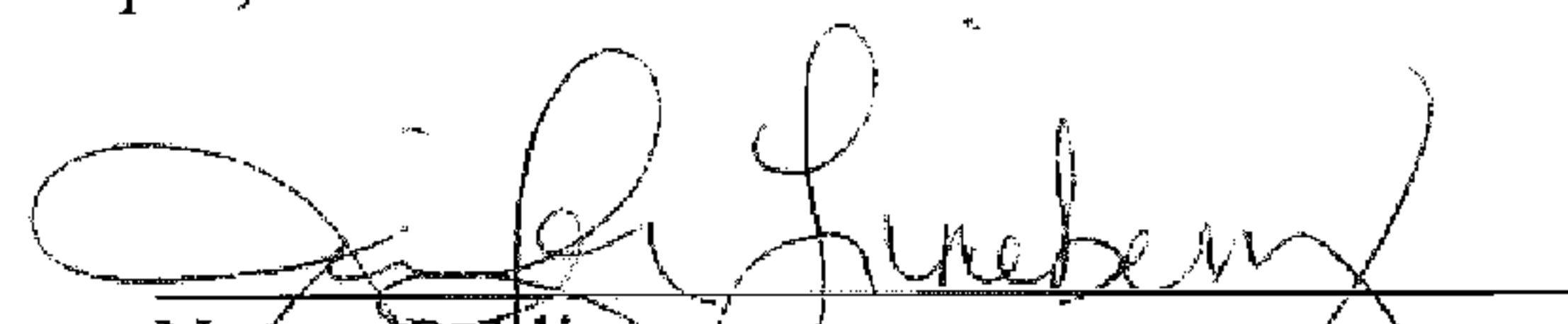
