WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

**STATE OF ALABAMA
COUNTY OF SHELBY**

KNOW ALL MEN BY THESE PRESENTS,

On this April 29, 2022, That for and in consideration of **THREE HUNDRED NINETY FIVE THOUSAND AND NO/100 (\$395,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **JEFFREY E. BERRY and KIMBERLY A. BERRY, husband and wife**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **COY PATRICK TROSCLAIR and ANGELA C. TROSCLAIR**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 32, according to the Survey of Wynlake Subdivision Phase II, as recorded in Map Book 20, Page 12A & B, in the Probate Office of Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2022 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantors.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 20, Page 12.
7. Building setback line of 35 feet reserved from Wynlake as per plat.
8. Utility easements as shown by recorded plat, including 7.5 feet on the easterly side and a 15 foot easement on the northerly side of lot.
9. Restrictions, covenants, and conditions as set out in Inst. No. 1995-30873 and Inst. No. 1995-30874, but omitting any covenants or restrictions, if any, based upon race, color, religion, sex, sexual orientation, familial status, marital status, disability
10. Easement(s) granted to Alabama Power Company as set out in Deed Book 101, Page 76, Deed Book 121, Page 191 and Deed Book 138, Page 317.
11. Title to all minerals within and underlying the premises, together with all mining rights and other rights, privileges and immunities relating thereto, including rights set out in Real 15, Page 375.



The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.
