KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration FOUR HUNDRED FORTY THOUSAND AND 00/100 (\$440,000.00), and other **good** and valuable consideration, this day in hand paid to the undersigned GRANTORS, **Nicholas G. Tudisco and Brittany Tudisco, husband and wife**, (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Daniel H. Ingber and Dana B. Ingber**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 397, according to the Survey of Hillsboro Subdivision, Phase III, as recorded in Map Book 39, Page 123 A, B, and C, in the Probate Office of Shelby County, Alabama.

\$343,200.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.





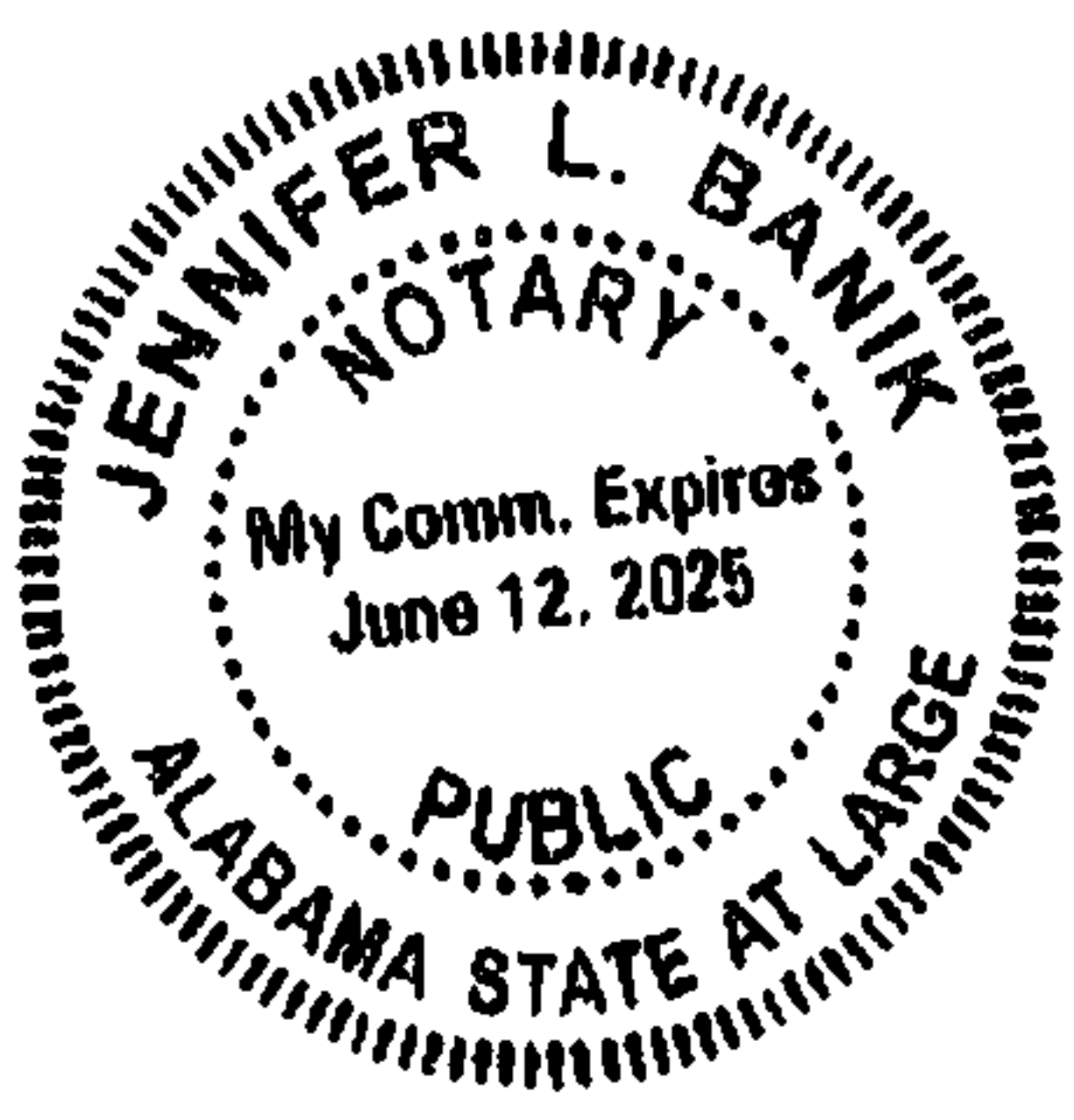
