For ad valorem tax purposes only, the address to the above-described property is 392 Strathaven Drive, Pelham, AL 35124.


To Have and to Hold to the said grantee, their assigns forever.

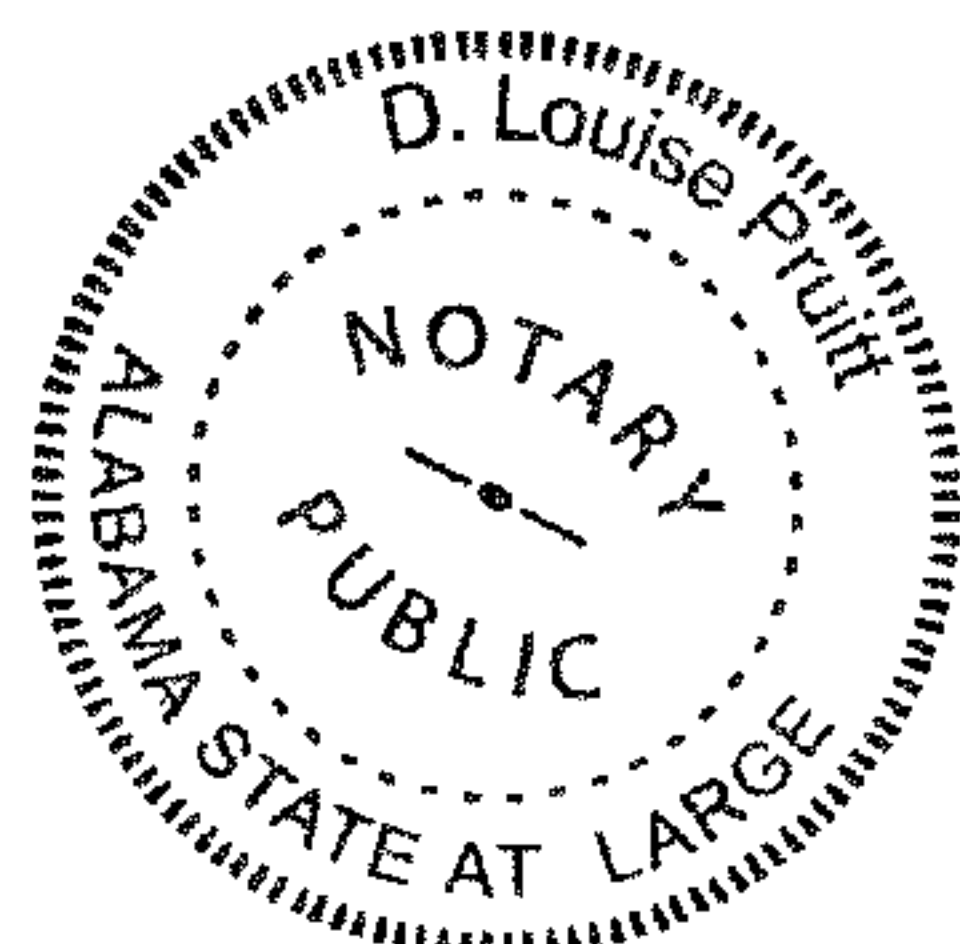
