GENERAL WARRANTY DEED
With Right of Survivorship

COUNTY OF Shelby } **KNOW ALL MEN BY THESE PRESENTS:**

THAT IN CONSIDERATION OF **Four Hundred Seventy-Five Thousand Dollars and NO/100 (\$475,000.00)** to the undersigned grantors, in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, **Bosang Kim and Kahyeong Lee, by and through Bosang Kim, her agent, husband and wife**, (herein referred to as Grantors), grant, sell, bargain and convey unto, **Wallace S. Wilson and Megan Wilson** (herein referred to as Grantees whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **Shelby County, Alabama** to wit:

Lot 15-A, A Re-Survey of Lots 14 and 15, according to the Survey of Oak Meadows, 1st Section, as recorded in Map Book 22, Page 137, in the Probate Office of Shelby County, Alabama.

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.

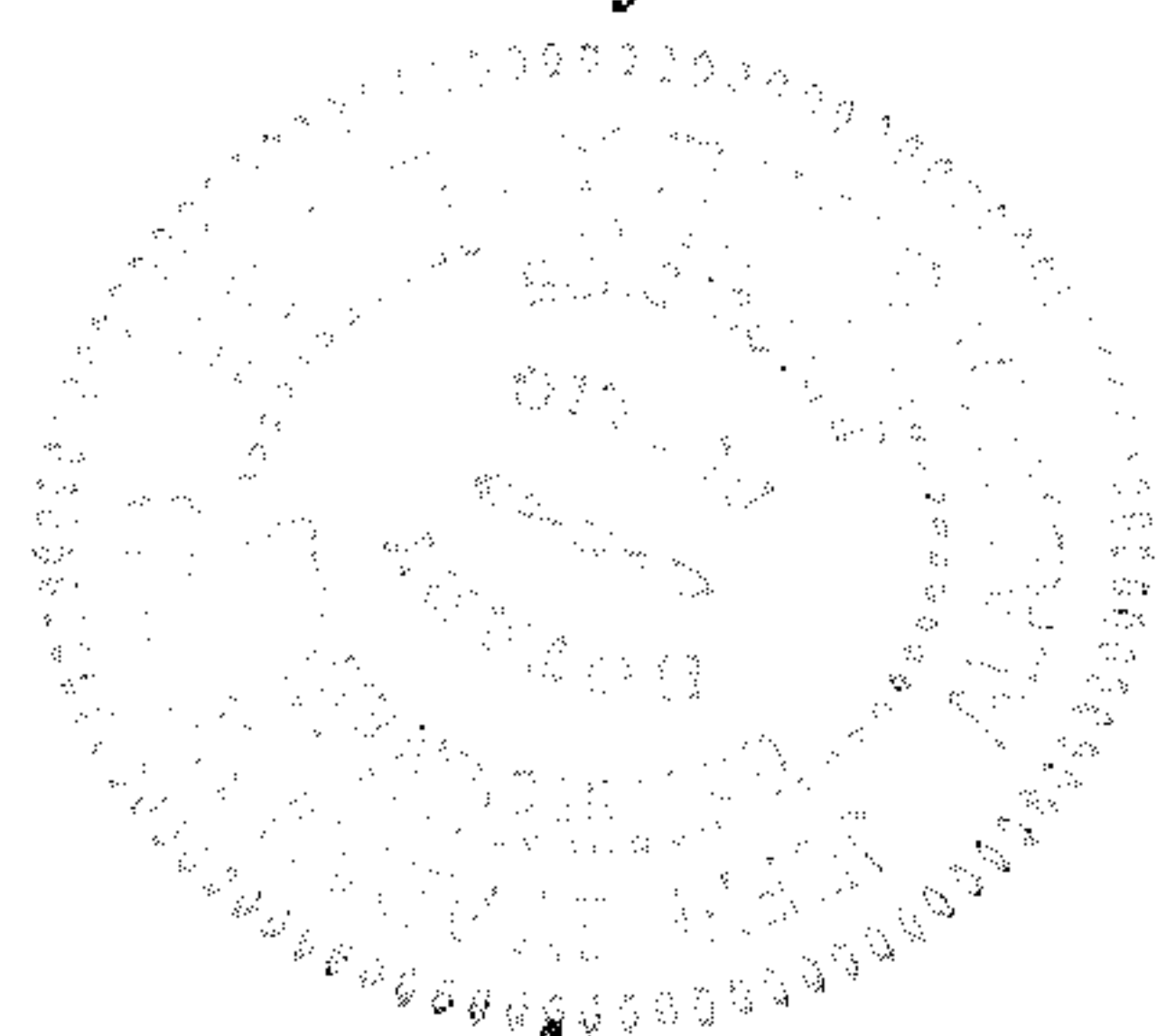

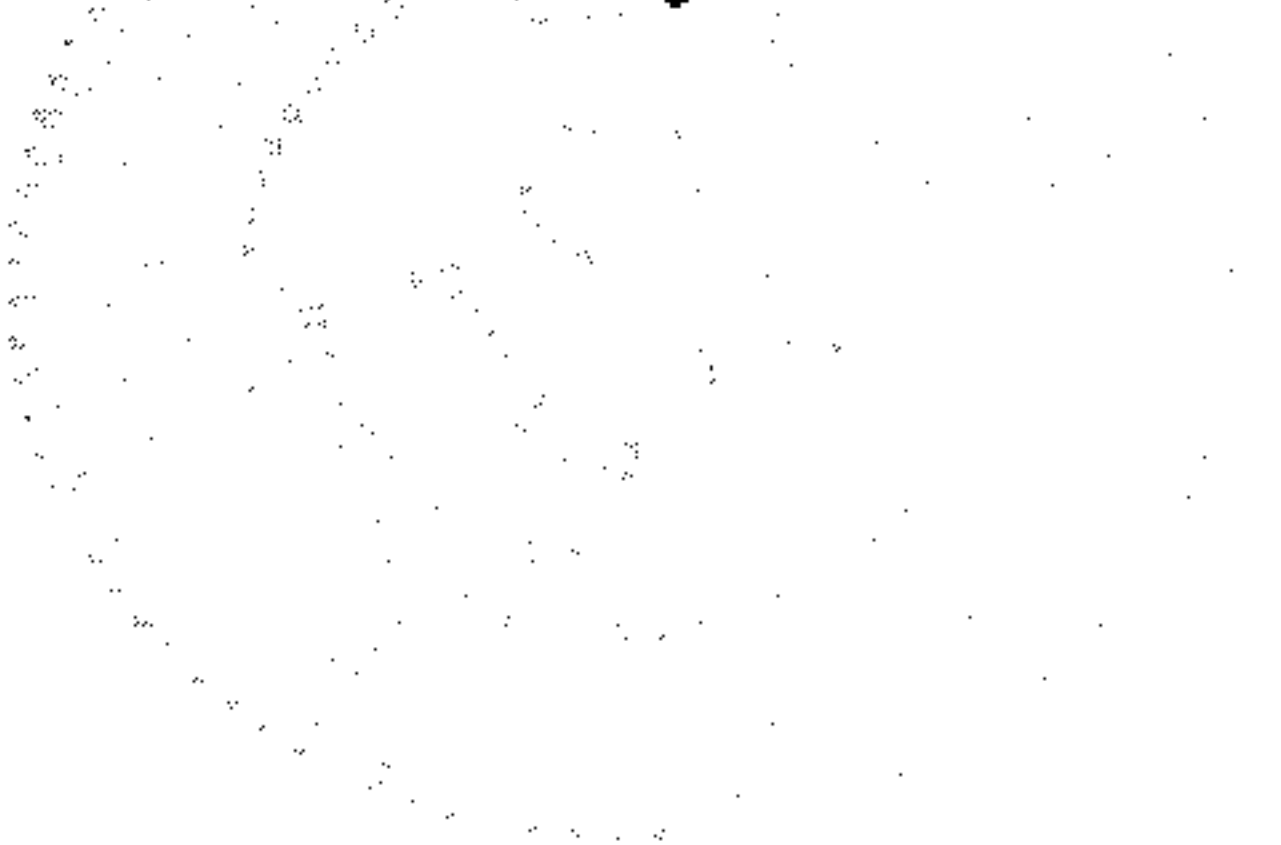
