Part 6. Trustee's Management Powers and Duties

Powers Under State Law

The trustee shall have all authority and powers allowed or conferred on a trustee under Alabama law, with the exception of powers of amendment, revocation and appointment, and subject to the trustee's fiduciary duty to the grantor and the beneficiaries.

Specified Powers

"Section 6. Rights, Responsibilities and Duties of Successor Trustees
