KNOW ALL MEN BY THESE PRESENTS, That in consideration of THIRTY THOUSAND DOLLARS AND NO CENTS (\$30,000.00), and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, we, **Helen Bush, a single woman** (herein referred to as **Grantors**) grant, bargain, sell and convey unto **Tracy Bush and Wanda Bush** (herein referred to as **Grantees**), the following described real estate, situated in: **SHELBY** County, Alabama, to-wit:

Lot 5 of the Helen Bush Family Subdivision, as recorded in Map Book 53, Page 30, Probate Office, Shelby County, Alabama.

SUBJECT TO:


