The undersigned Trustee hereby certifies the following:



The actions and authority exercised by either Trustee on behalf of the Trust shall be binding upon both Trustees and may be relied and acted upon by any third party.

All persons relying on this document regarding the Trustees and their power over trust property shall be held harmless for any resulting loss or liability from such reliance. A copy of this Certificate of Trust shall be just as valid as the original.


