
Subject to a third-party mortgage in the amount of \$365,920.00 executed and recorded simultaneously herewith.

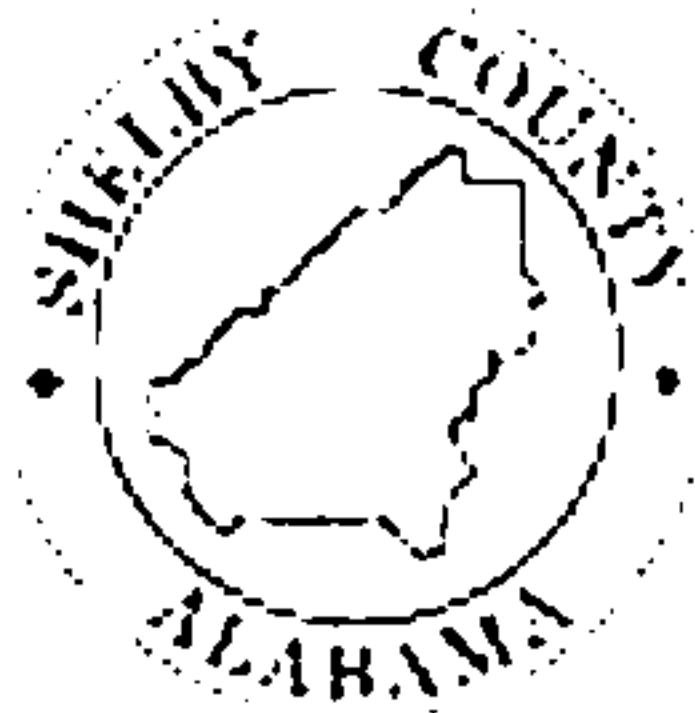
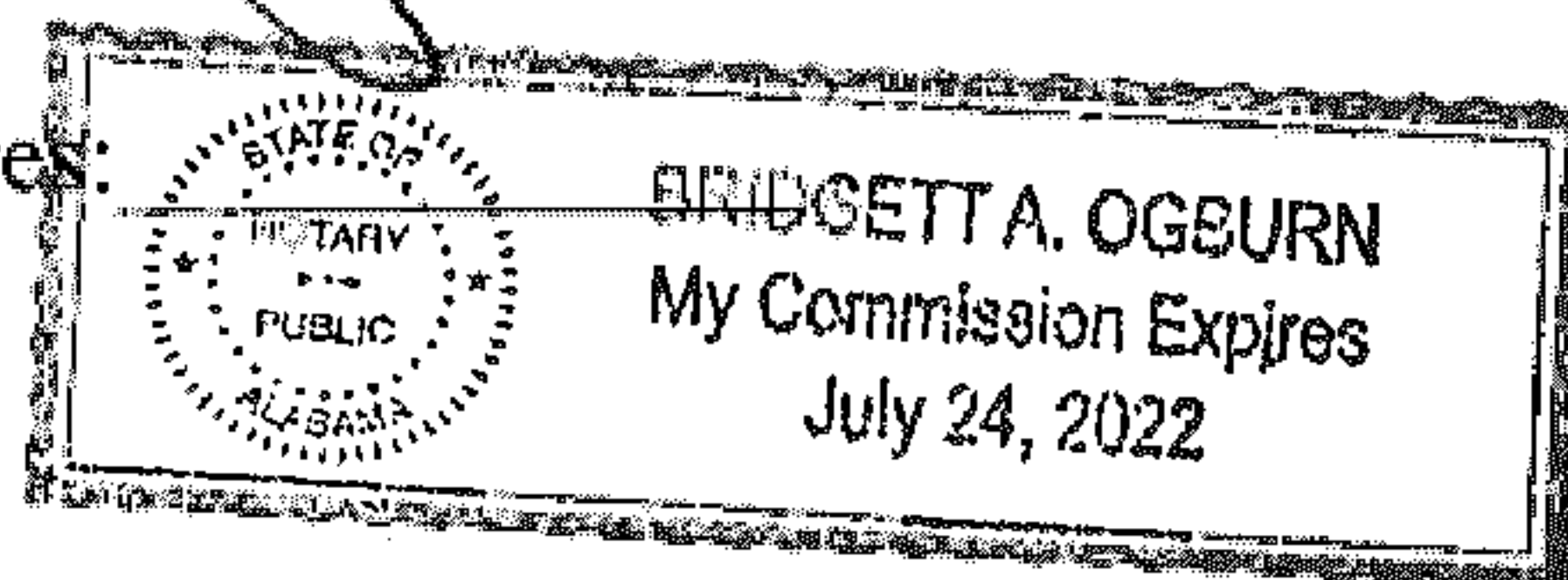
