ABSTRACT AND CERTIFICATION OF TRUST

The undersigned hereby certifies that on **July 17, 2009**, they created revocable estate planning Trust. This Trust is known as: **The Gibbons Family Trust, dated July 17, 2009, Alen Gibbons and Christine Gibbons, Trustors and/or Trustees, f.b.o. the Gibbons Family.**

THE PARTIES FURTHER DECLARE AND CERTIFY AS FOLLOWS:

Description of Trust

The parties hereto desire to confirm the establishment of a revocable Trust on **July 17, 2009**, and amendments thereto, for the benefit of the Trustors (as husband and wife) and containing inter alia the following provisions:

1. The Trustors are designation as the Trustees to serve until both their deaths, resignations or incompetence. The Trustors are authorized to act independently in the name of the Trust.
2. Upon the removal of both original Trustees, the Successor Trustee is designated as **Junius N. Gibbons**
3. Upon the death of a/both original Trustees, the Trust property is held and administered as necessary by its terms. The Trustee may make elections and allocations in the Trust in such a manner as to qualify for an alternate valuation date under Internal Revenue Code Section 2032.
4. The Trustees/Trustors have the power and authority to manage and control, buy, sell and transfer the Trust property, in such manner as the Trustees may deem advisable, and shall have, enjoy and exercise all powers and rights over and concerning said property and the proceeds thereof as fully and amply as though said Trustees were the absolute and unqualified owner of same, including the power to grant, bargain, sell and convey, encumber and hypothecate, real and personal property, and the power to invest in corporation obligations of every kind, stocks, preferred or common, and to buy stocks, bonds, and similar investments on margin or other leveraged accounts, except to the extent that such management would cause inclusion of an irrevocable trust in the estate of a Trustee.
5. Following the death of the Trustors, the Trust continues or is distributed in whole or in part for the benefit of other named beneficiaries according to the terms of the Trust.

6. While the Trustor(s) are living and competent, except when there should be a Corporate Trustee, the Trustees may add money to or withdraw money from any bank or savings and loan or checking account owned by the Trust.
7. All property transferred into the Trust which had an original source as separate property remains the separate property of a Trustor unless other provisions shall have been made therefor.
8. All personal property transferred into trust remains personal property and all real property transferred into Trust remains real property.
9. Unless otherwise indicated to a prospective transferee, the Trustees have full per to transfer assets held in the name of the Trust and subsequent transferees are entitled to rely upon such transfers provided the chain of title is not otherwise deficient.
10. While the Trustors/Trustees survive, they will use their own Social Security Numbers as the tax identification number on all accounts held in the name of the Trust [United States Treasury Regulations, Section 1.671-3(a)(1)]. Specifically:


11. The situs of the Trust is the State of **California**.

12. This Trust contains Spendthrift provision.


