JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

) Know All Men by These Presents:

County of Shelby

That in consideration of the sum of **Four Hundred Forty Thousand Dollars and No Cents (\$440,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Brian Bell and Rachel Bell**, husband and wife (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **James K. Holly and Dell A. Holly**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 2, according to the survey of Lake Kathryn Sector Two, as recorded in Map Book 24, Page 140, in the Probate Office of Shelby County, Alabama.

Property may be subject to taxes for 2022 and subsequent years, all covenants, restrictions, conditions, easements, liens, set back lines, and other rights of whatever nature, recorded, and/or unrecorded.

\$440,000.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.

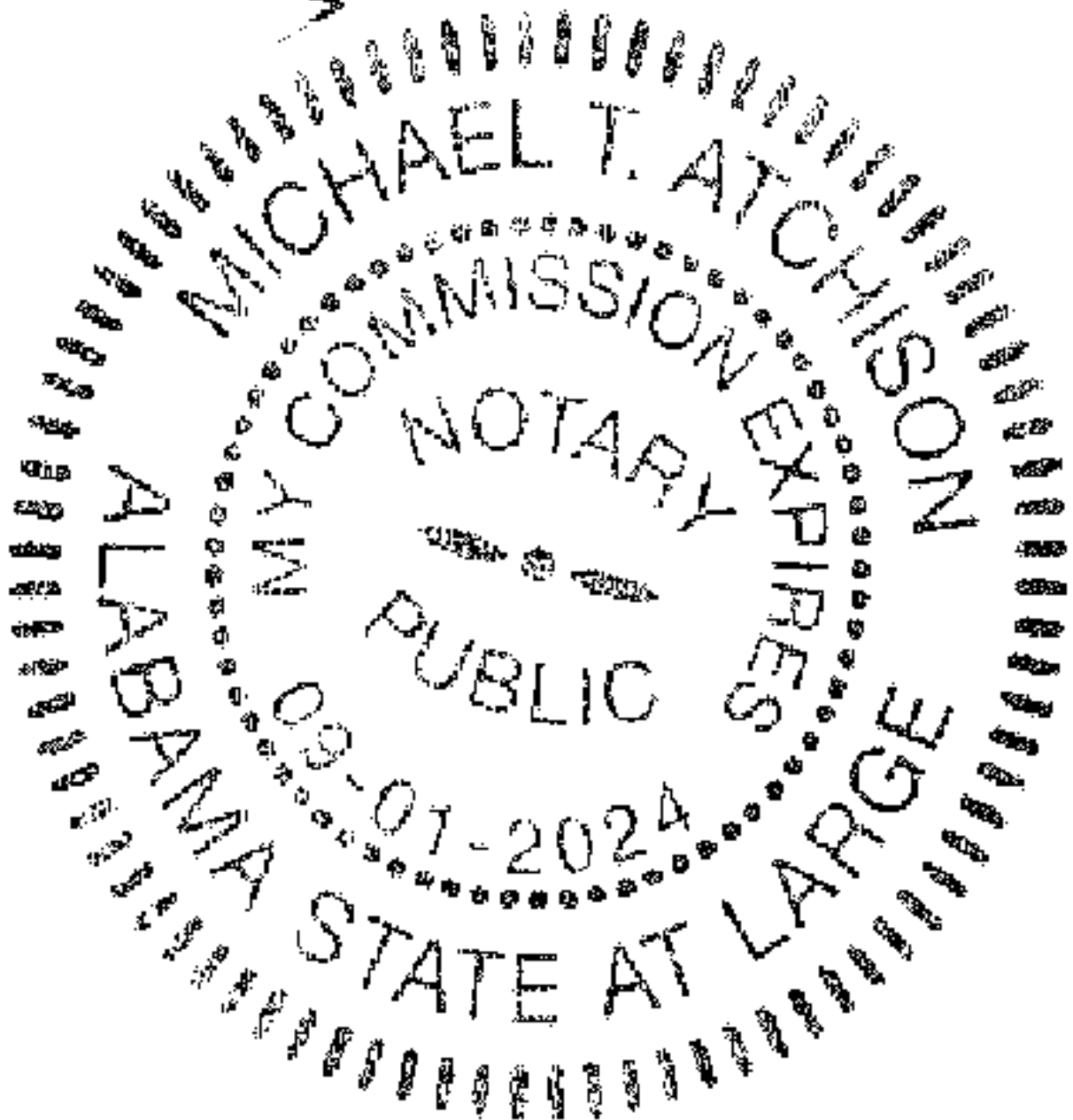

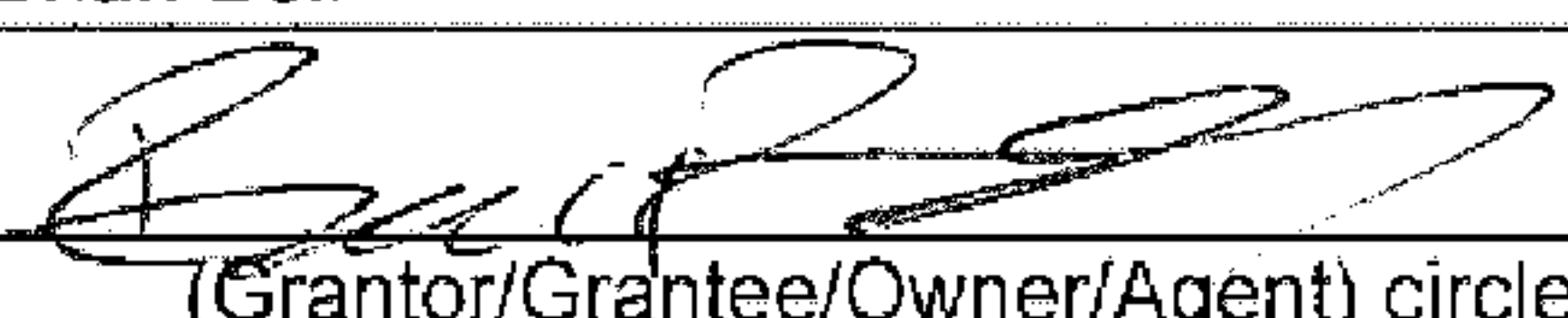
