Chambless and wife, Cynthia Chambless**, (herein referred to as grantor(s), whether one or more), grant, bargain, sell and convey to **McKenna Stone Marshall and Philip Andrew Marshall**, hereinafter referred to as grantee(s), whether one or more), the following described real estate situated in Shelby County, Alabama to-wit:

\$223,378.00 of the purchase price recited herein was paid from the proceeds of a purchase money mortgage closed simultaneously herewith.

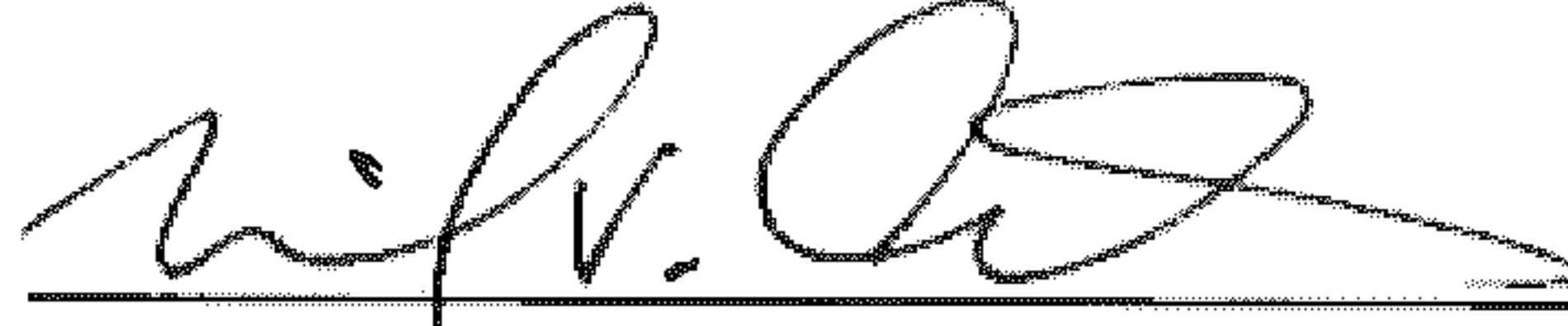

2. Easements, restrictions, reservations and conditions of record.

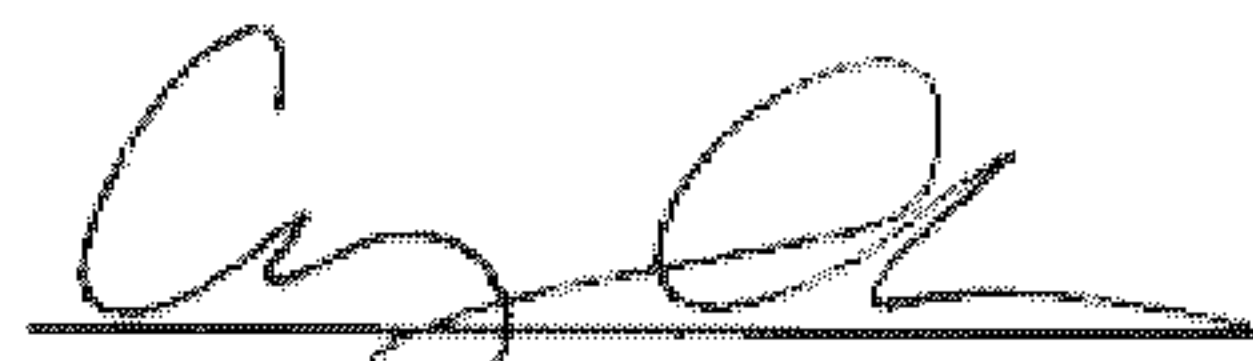

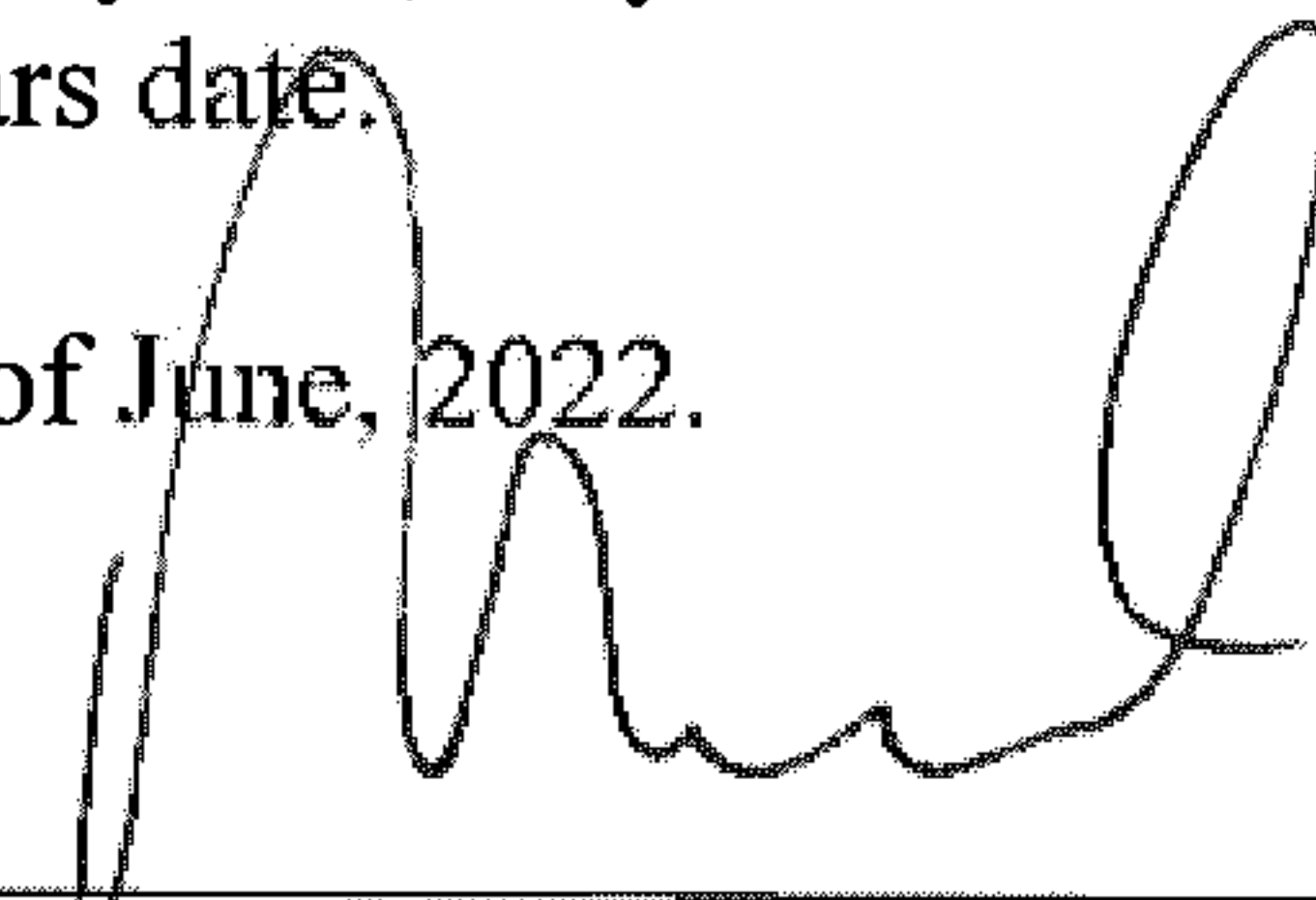

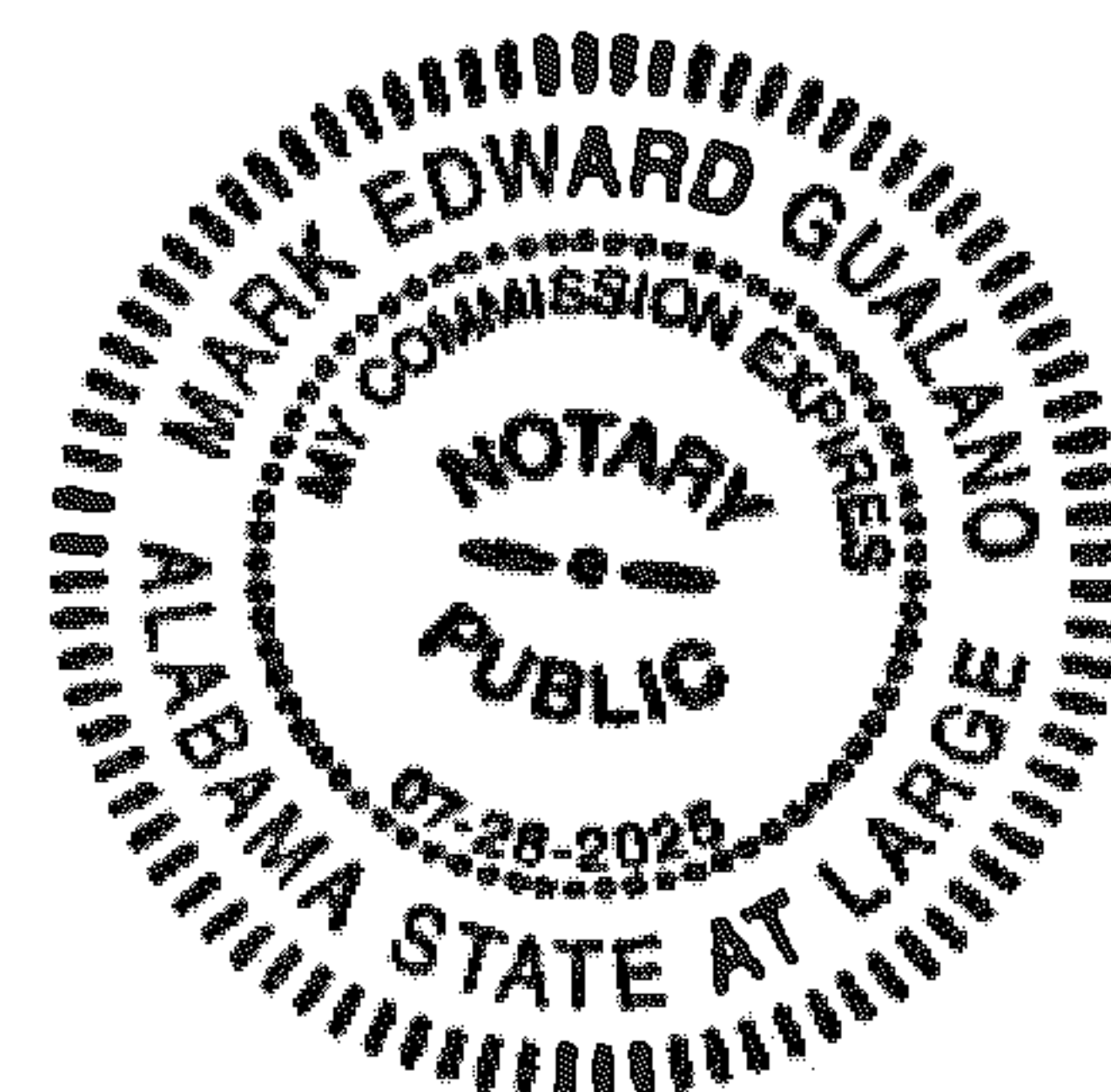
