(herein referred to as Grantor, whether one or more), grant, bargain, sell, and convey unto

ATHENA CHANG, TRUSTEE, OR HER SUCCESSOR IN TRUST, UNDER THE CHANG LIVING TRUST, DATED JANUARY 12, 2005, AND ANY AMENDMENTS THERETO,

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 462, according to the Map and Survey of the Final Plat Forest Lakes, Sector 5, as recorded in Map Book 34, Page 122, A, B & C, in the Office of the Judge of Probate of Shelby County, Alabama.


Subject to taxes, restrictions, rights-of-way, exceptions, conditions, covenants and easements of record.




