THAT IN CONSIDERATION OF **Four Hundred Ninety-Five Thousand Dollars and NO/100 (\$495,000.00)** to the undersigned grantors, in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, **Lyndsie Turner Curry and Andrew Mark Curry, wife and husband**, (herein referred to as Grantors), grant, sell, bargain and convey unto, **Benjamin Caleb Cox and Laura Katherine Cox** (herein referred to as Grantees whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in a Shelby County, Alabama to wit:

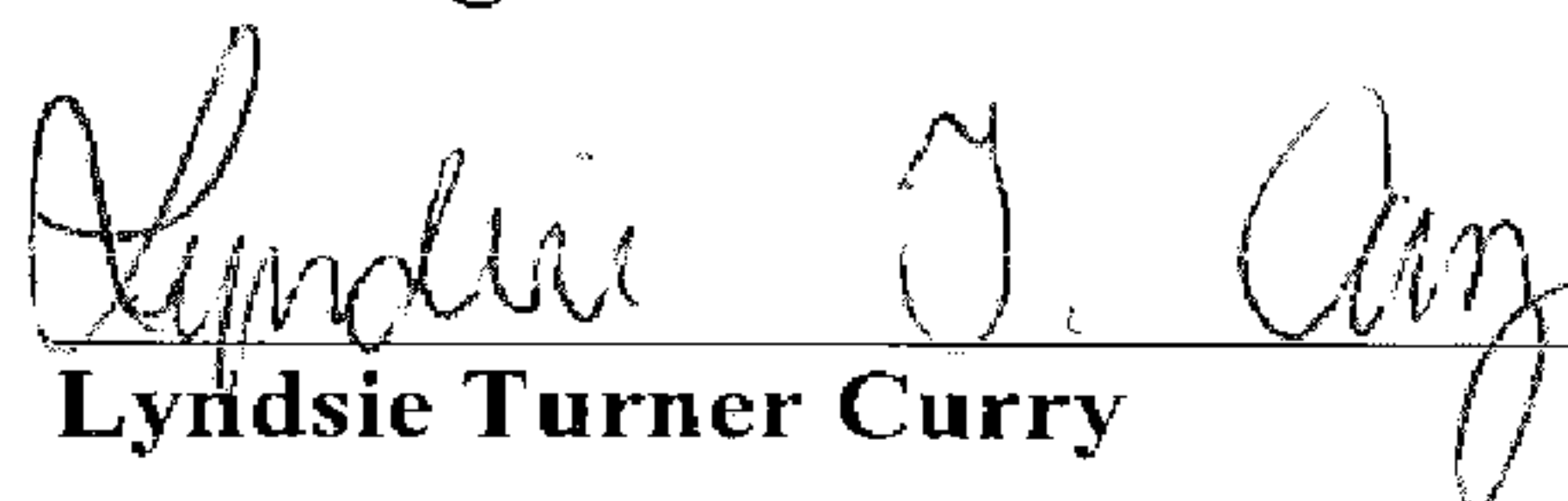
Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.
