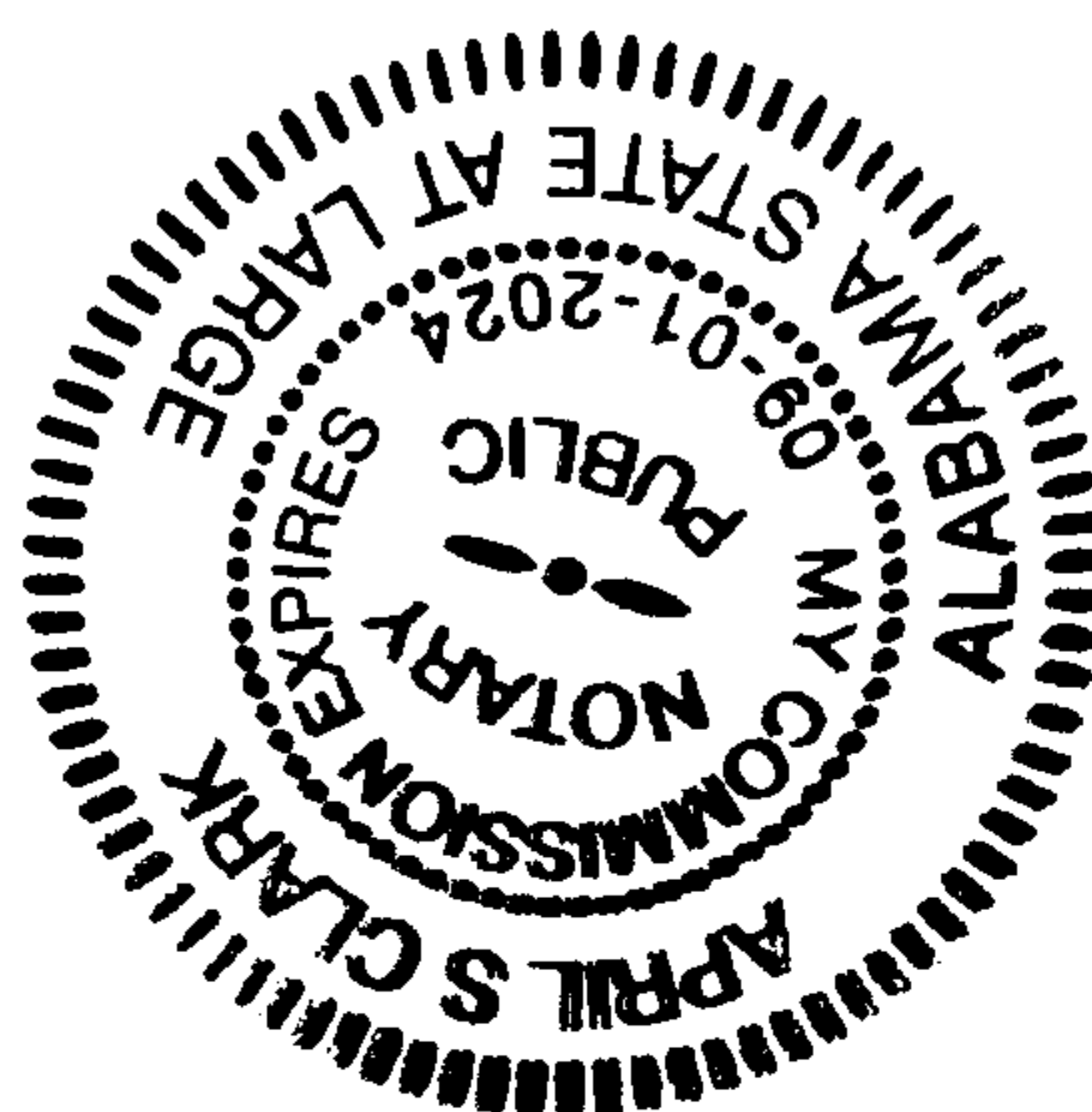
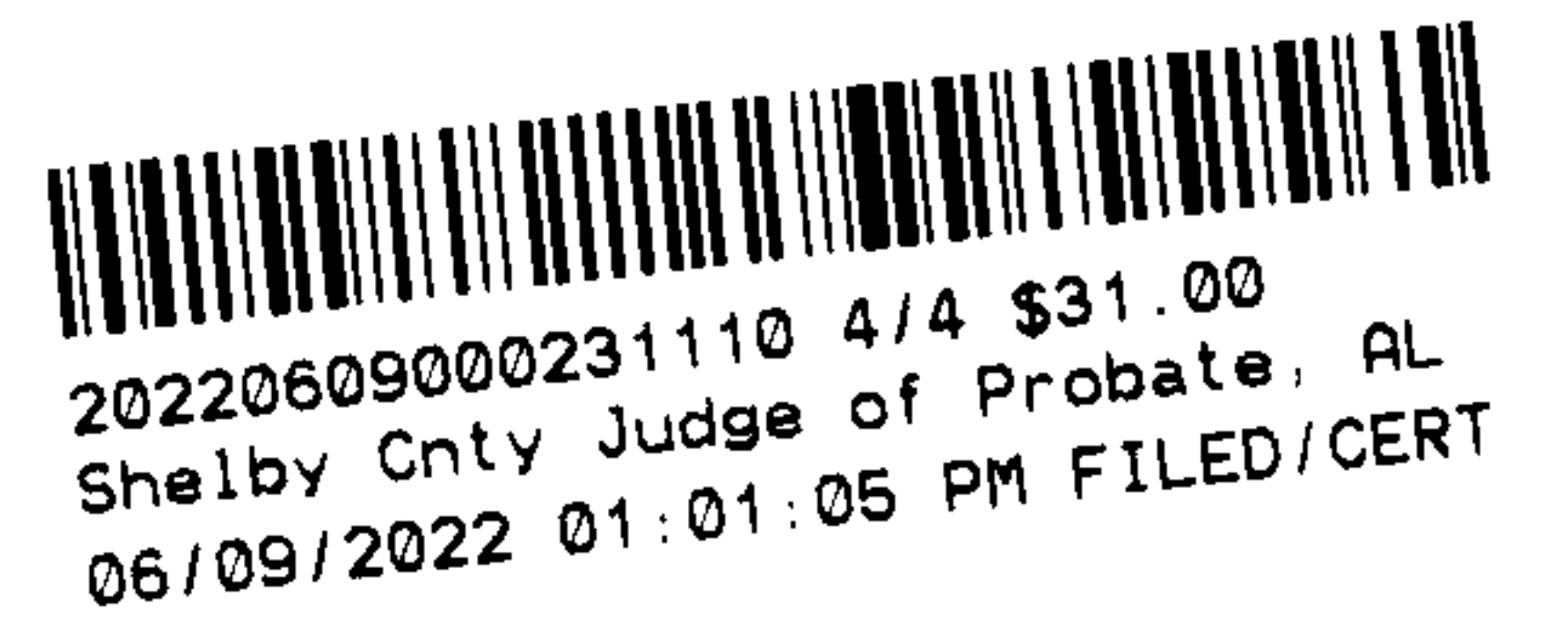


EXHIBIT A – LEGAL DESCRIPTION



A parcel of land lying in the SW 1/4 of the SE 1/4, Section 19 Township 20 South, Range 2 East, and more particularly described as follows:
Starting at the Southeast corner of the said SW 1/4 of the SE 1/4 of Section 19, Township 20 South, Range 2 East, which is the point of beginning, run Westerly along the South boundary line of said SW 1/4 of SE 1/4 a distance of 1,331.3 feet to an iron marker at the Southwest corner of said SW 1/4 of SE 1/4, Thence turn 90 degrees 15 minutes right and run Northerly for 1,082.5 feet to an iron marker. Thence turn 89 degrees 45 minutes right and run Easterly for 665.6 feet to an iron marker. Thence turn 90 degrees 15 minutes right and run Southerly for 834.0 feet to an iron marker. Thence turn 90 degrees 15 minutes left and run Easterly for 665.6 feet to an iron marker on the East boundary line of said SW 1/4 of SE 1/4. Thence turn 90 degrees 15 minutes right and run Southerly along the said East boundary line of said SW 1/4 of SE 1/4 a distance of 249.0 feet to the point of beginning. Said parcel of land lies in the said SW 1/4 of SE 1/4, Section 19, Township 20 South, Range 2 East.
