Lot 2, according to the Survey of Cartville Estates as recorded in Map Book 56, Page 24, in the Probate Office of Shelby County, Alabama.

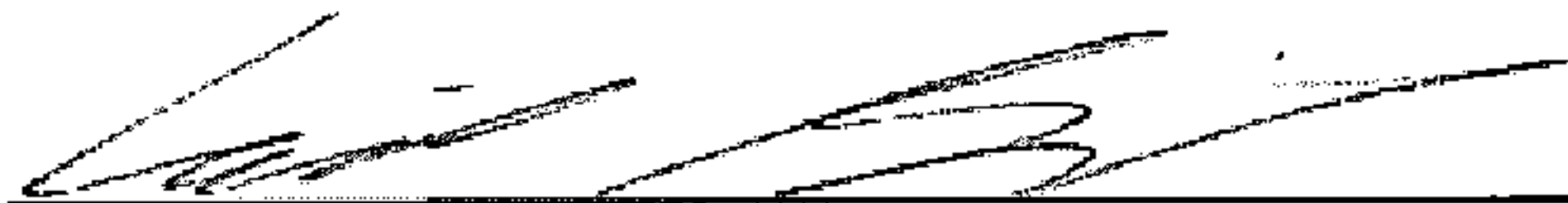

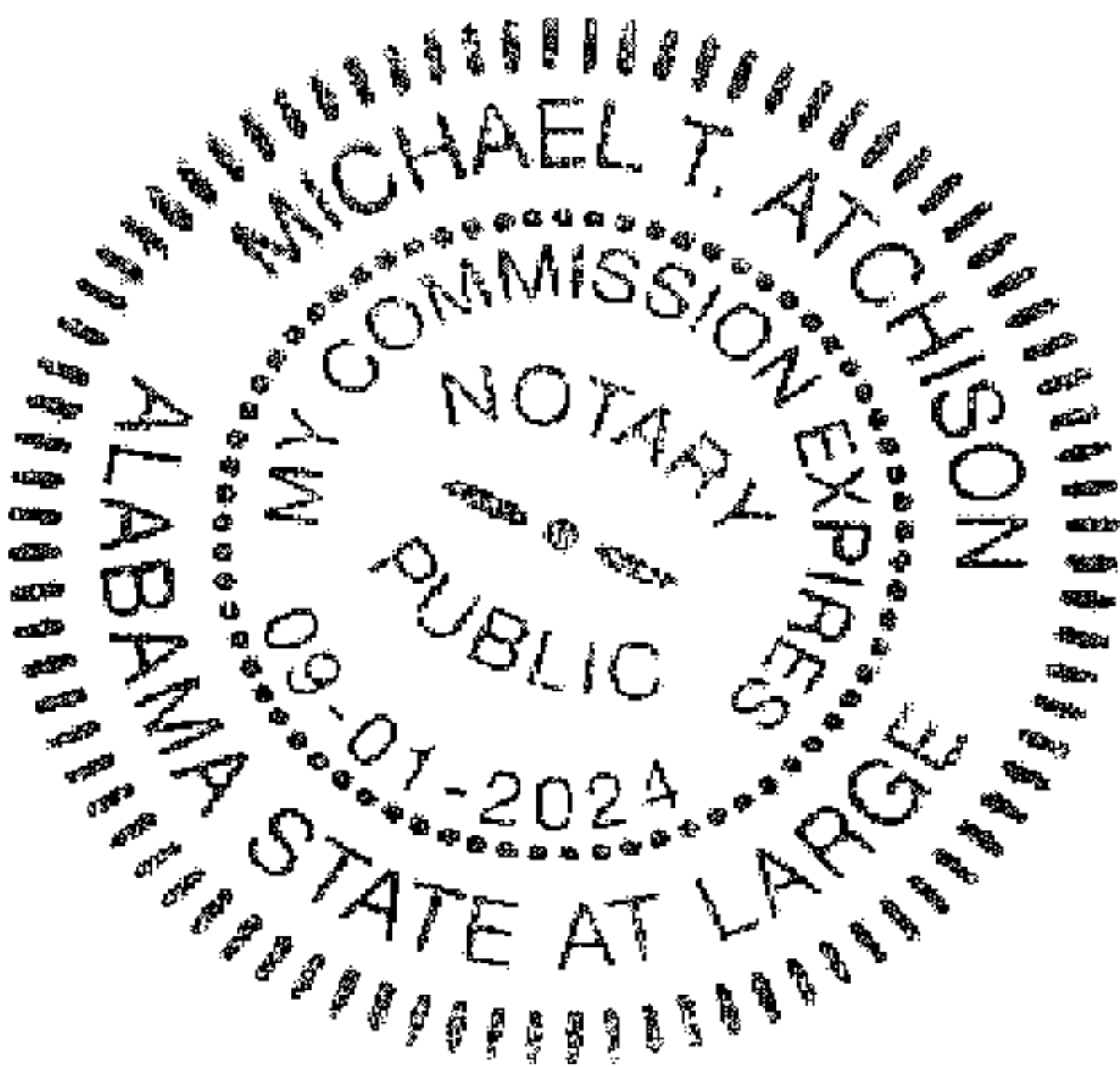
