Know All Men by These Presents: That in consideration of **Five Hundred Eighteen Thousand Nine Hundred and no/100 Dollars (\$518,900.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **DONOVAN BUILDERS, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **JOSHUA MICHAEL GIRARDIN and KARLA GIRARDIN** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

Lot 610, according to the Final Plat of Grey Oaks Subdivision, Phase 6, as recorded in Map Book 53, Page 78 A and B, in the Probate Office of Shelby County, Alabama.

And the Grantor does for itself, its successors and assigns, covenant with said Grantees, their heirs and assigns, that it is lawfully seized in fee simple of said premises; that it is free from all encumbrances, unless otherwise stated above; that it has a good right to sell and convey the same as aforesaid; that it will and its successors and assigns shall warrant and defend the same to the said Grantees, their heirs and assigns forever, against the lawful claims of all persons.

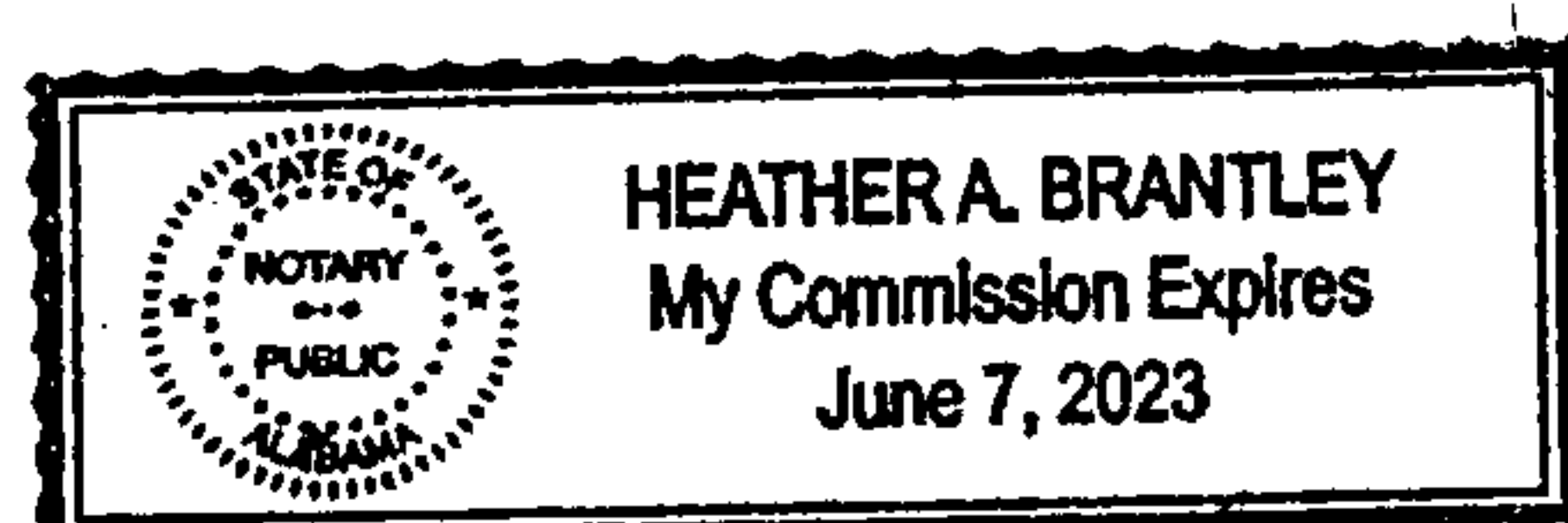
