WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Eight Hundred Seventy Nine Thousand Nine Hundred and 00/100 Dollars (\$879,900.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

Cody D. Marcum, and his wife, Kristin N. Marcum

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Chad Gottier and Kimberly Gottier

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 22-03, Block 22, according to the Survey of Mt. Laurel, Phase IIIB, Sector 2, as recorded in Map Book 41, Page 44, in the Probate Office of Shelby County, Alabama.

\$368,000.00 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to: (1) 2022 ad valorem taxes not yet due and payable;
 (2) all mineral and mining rights not owned by the Grantors; and
 (3) all easements, rights-of-way, restrictions, covenants and
 encumbrances of record.

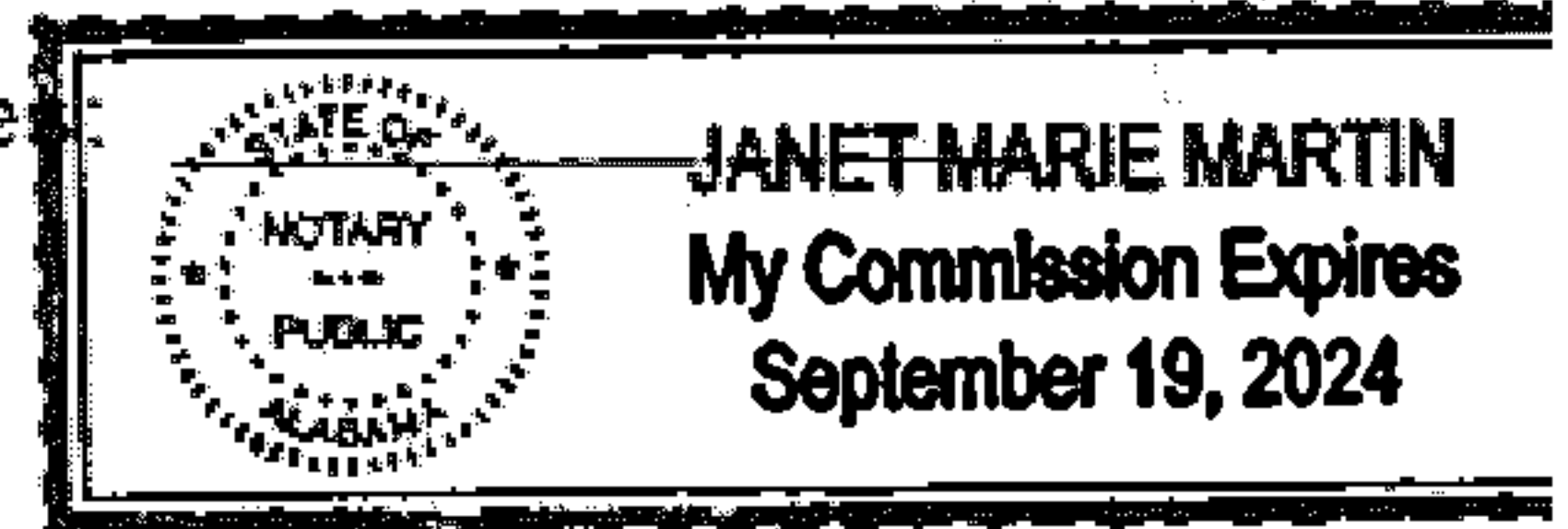
