THAT IN CONSIDERATION OF Seven Hundred Fifty Nine Thousand Nine Hundred and No/100(\$759,900.00) to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, **Gregory Holdings, LLC** (herein referred to as grantors) do grant, bargain, sell and convey unto **Derrick Davis and Sherri Davis**(herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

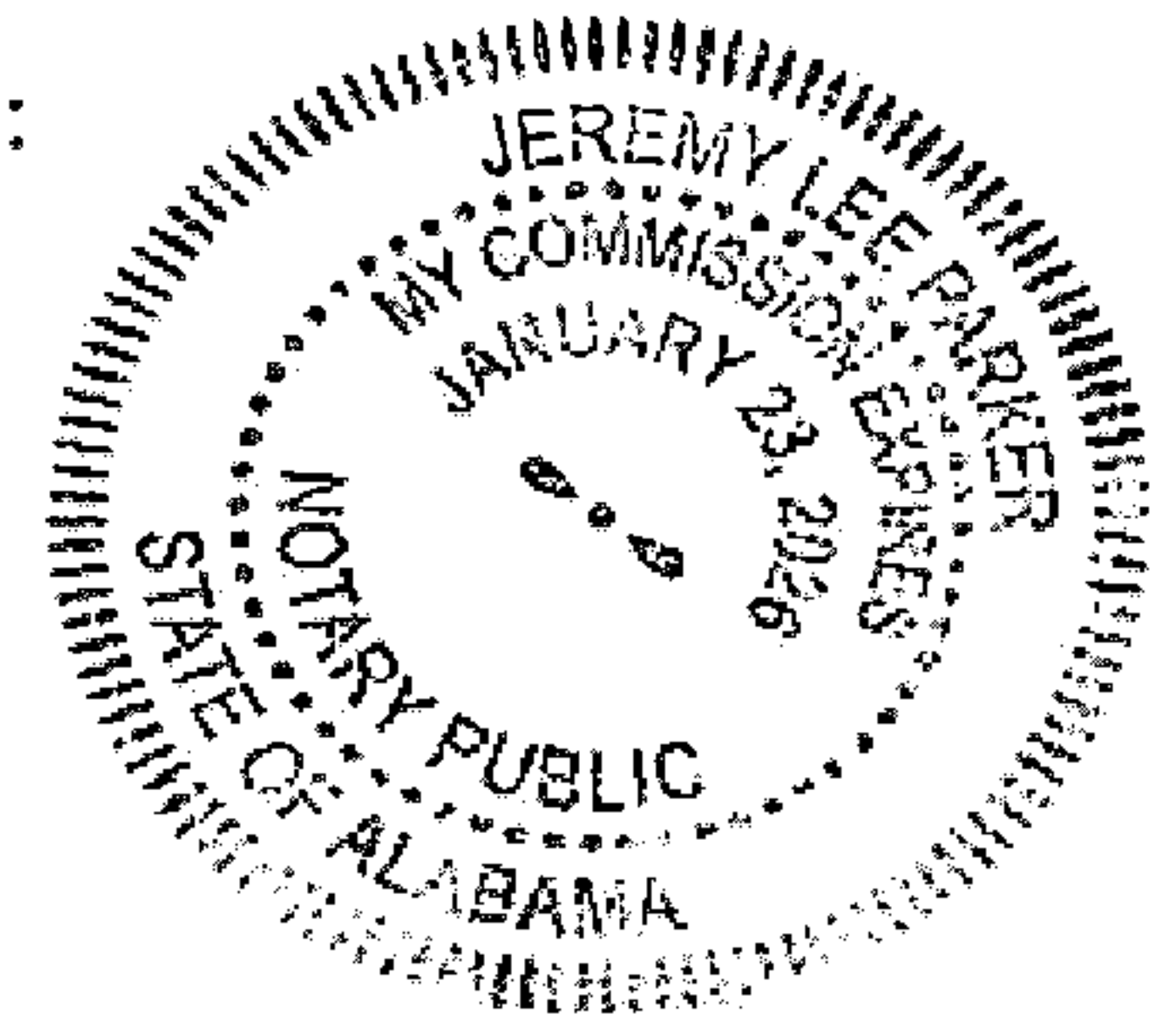
