

## **LEGAL DESCRIPTION**

Property ID: Commence at a 2 ½ " open pipe found at the Southwest corner of the Northeast ¼ of Section 30, Township 18 South, Range 2 East, Shelby County, Alabama; thence N2 degrees 32'30"W, assumed, along the West line of said ¼ 573.50 feet to the Northerly right of way line of Alabama Highway 25, being the POINT OF BEGINNING: thence continue N2 degrees 32'30"W along said line 1294.71 feet to a 5/8" rebar set on the Southerly right of way line of Norfolk-Southern Railroad; thence S48 degrees 17'00"E along said line 862.15 feet to a railroad rail found; thence N48 degrees 59'46"E along said line 99.59 feet to a railroad rail found at the point of curvature of a non-tangent curve, concave to the Northeast, having a radius of 11287.26 feet, a central angle of 1 degrees 38'18" and a chord of 322.72 feet bearing S56 degrees 54'36"E; thence Southeast along said curve and line 322.73 feet to a 5/8" rebar set; thence S58 degrees 49'23"W 635.15 feet to a 5/8" rebar set; thence S29 degrees 31'25"W a distance of 429.90 feet to a 5/8" rebar set on the Northerly right of way line of Alabama Highway 25; thence N59 degrees 56'11"W along said line 54.13 feet to a 5/8" rebar set at the point of curvature of a tangent curve, concave to the Southwest, having a radius of 1515.88 feet, a central angle of 5 degrees 30'48" and a chord of 145.81 feet bearing N 62 degrees 41'35"W; thence Northwest along said curve and line 145.87 feet to the POINT OF BEGINNING.
