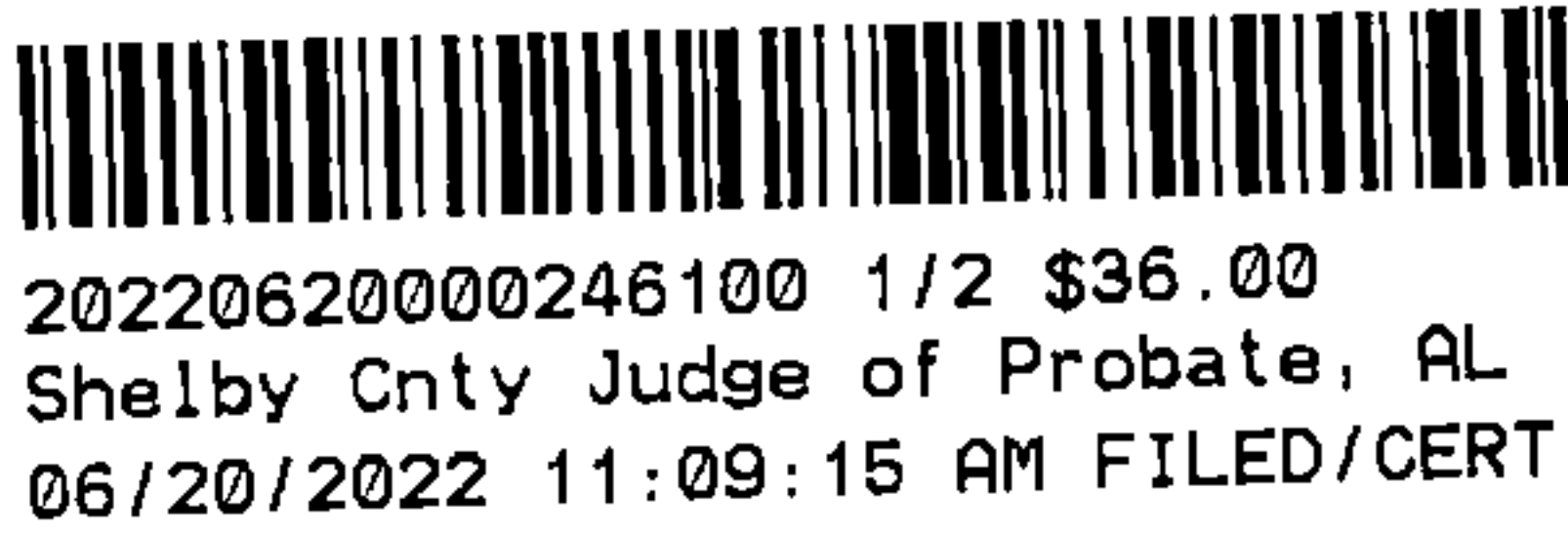

That in consideration of TEN THOUSAND DOLLARS AND OTHER GOOD AND VALUABLE CONSIDERATION to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we,

(herein referred to as Grantor, whether one or more), grant, bargain, sell, and convey unto

MICHAEL A. WIDRA AND MELINDA M. WIDRA, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE WIDRA LIVING TRUST, DATED JUNE 13, 2022, AND ANY AMENDMENTS THERETO.

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

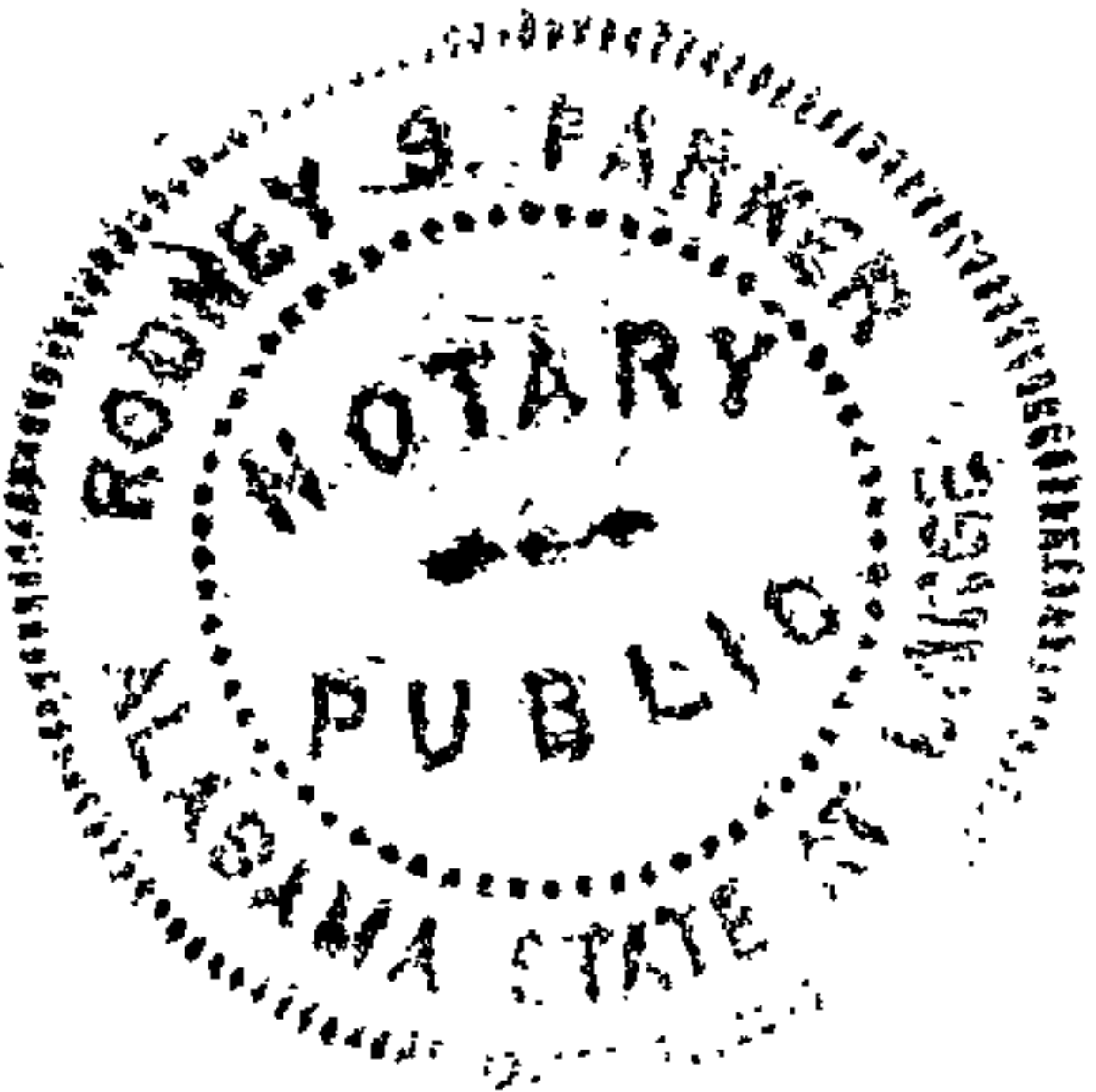
