
SUBJECT TO:

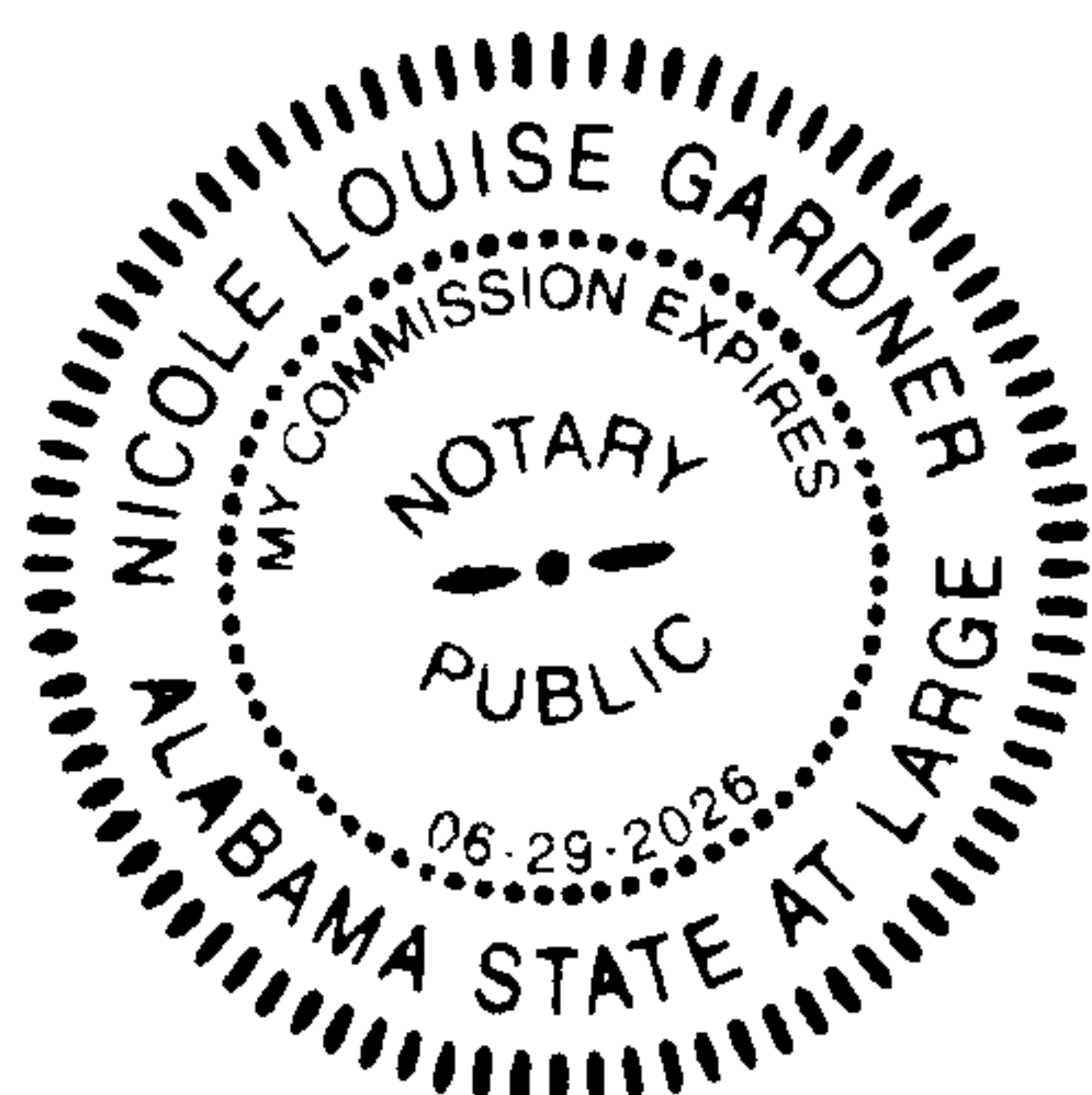



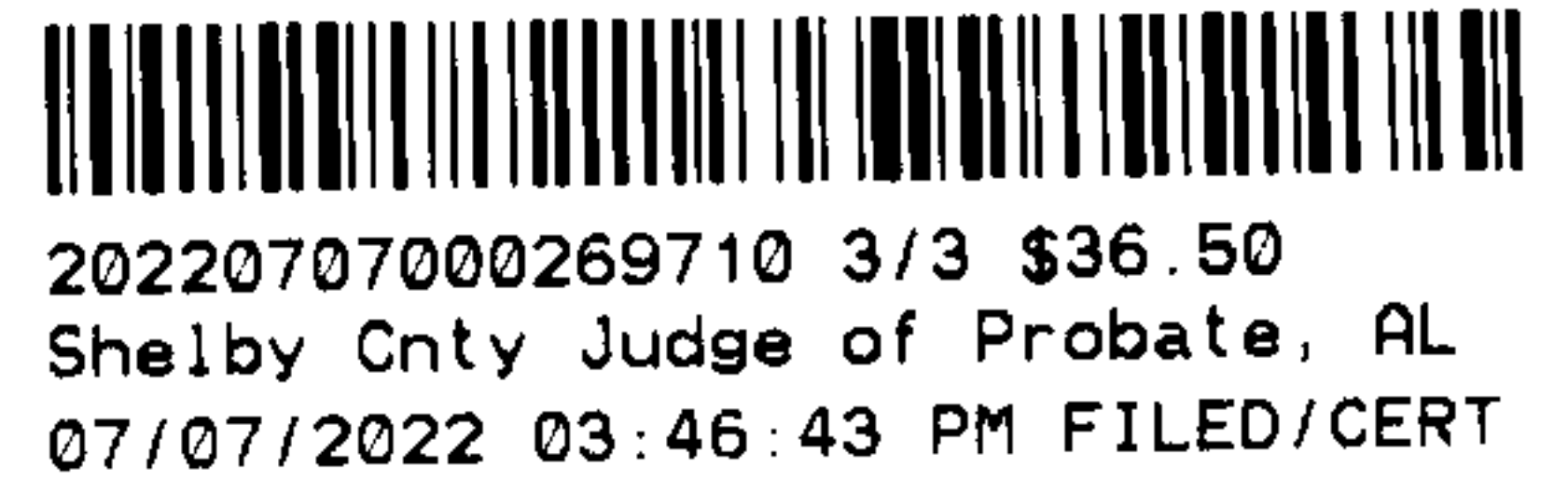
