Know All Men by These Presents: That in consideration of **Five Hundred Fifty-Eight Thousand Seven Hundred Forty-Seven and 18/100 Dollars (\$558,747.18)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **DONOVAN BUILDERS, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **TODD F. SPARROW and JAMIE SPARROW** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

Lot 528, according to the Final Plat of Grey Oaks Subdivision, Sector 5, as recorded in Map Book 55, Page 3, in the Probate Office of Shelby County, Alabama.

Subject to mineral and mining rights if not owned by Grantor. Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.

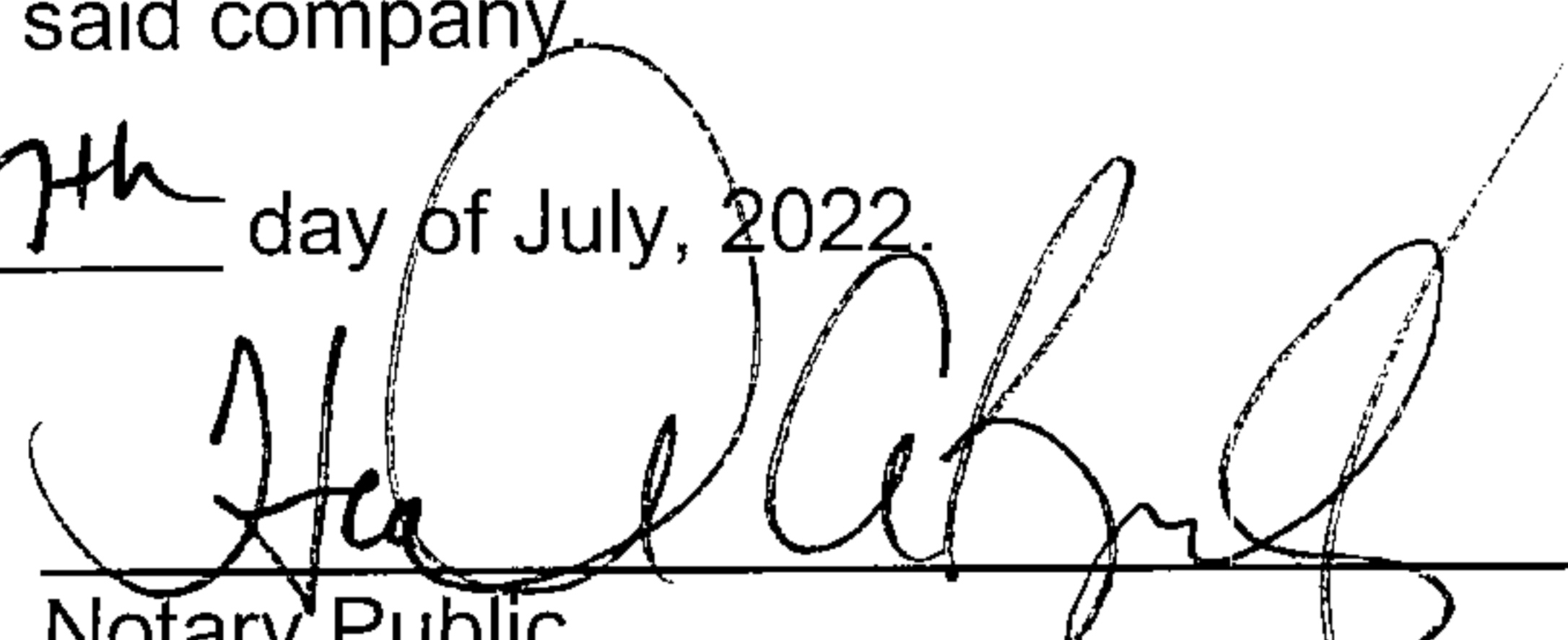
