HARTSELL, HUSBAND AND WIFE** (hereinafter referred to as "Grantor") does by these presents grant, bargain, sell and convey unto **LUCINDA H. LOUDERBACK** (hereinafter referred to as "Grantee", whether one or more) the following described real estate, situated in Shelby County, Alabama.

NOTE: \$260,000.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.






