**Lot 1, according to the survey of Blair Farms, a subdivision situated in the NE ¼ of Section 28, Township 21 South, Range 1 East, Shelby County, Alabama, as recorded in Map Book 56, Page 56, in the Probate Office of Shelby County, Alabama.**

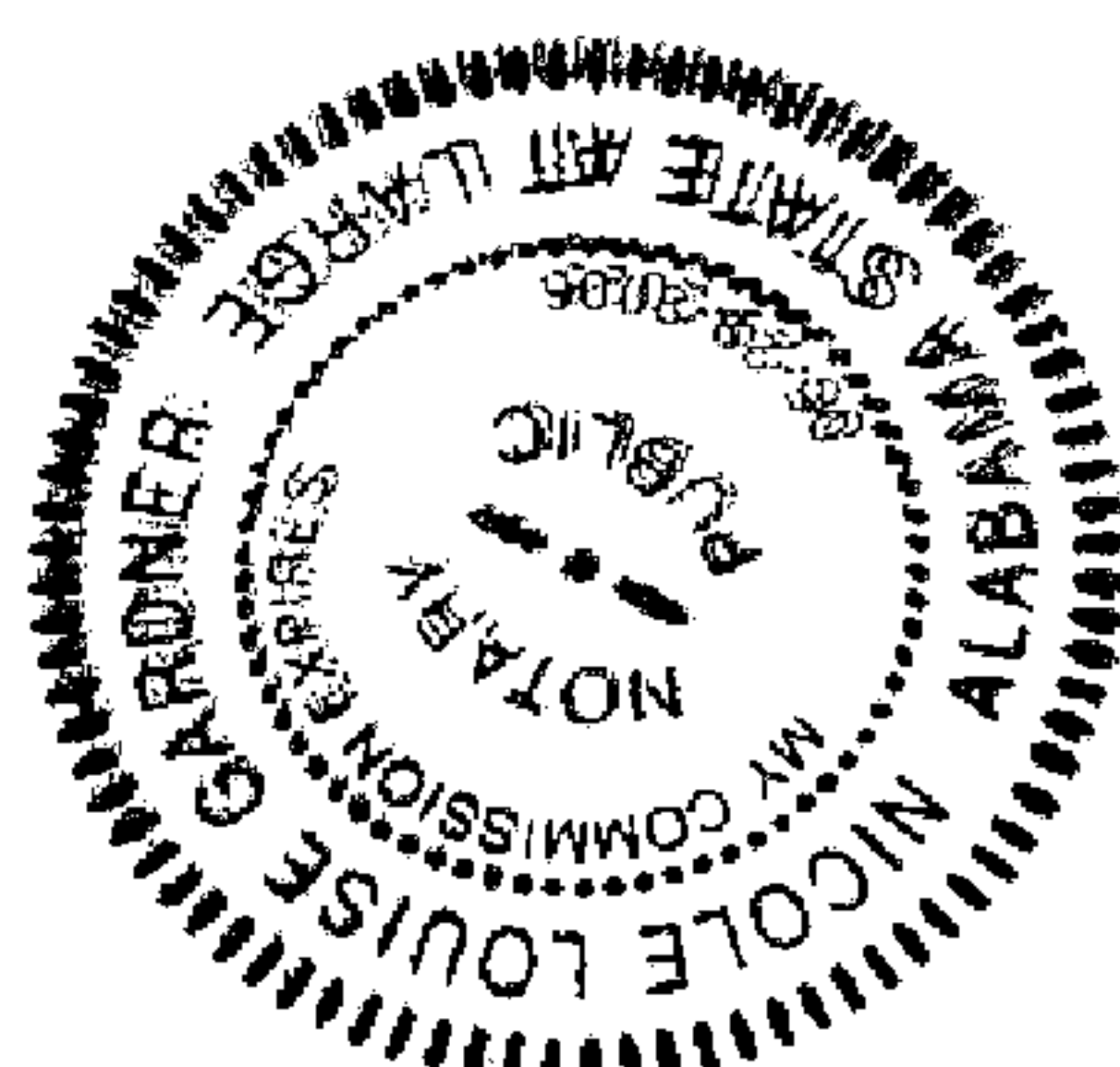
