Lot 2, Wood Ridge Estates, Map Book 56, Page 57 in the Probate Office of Shelby County, Alabama.





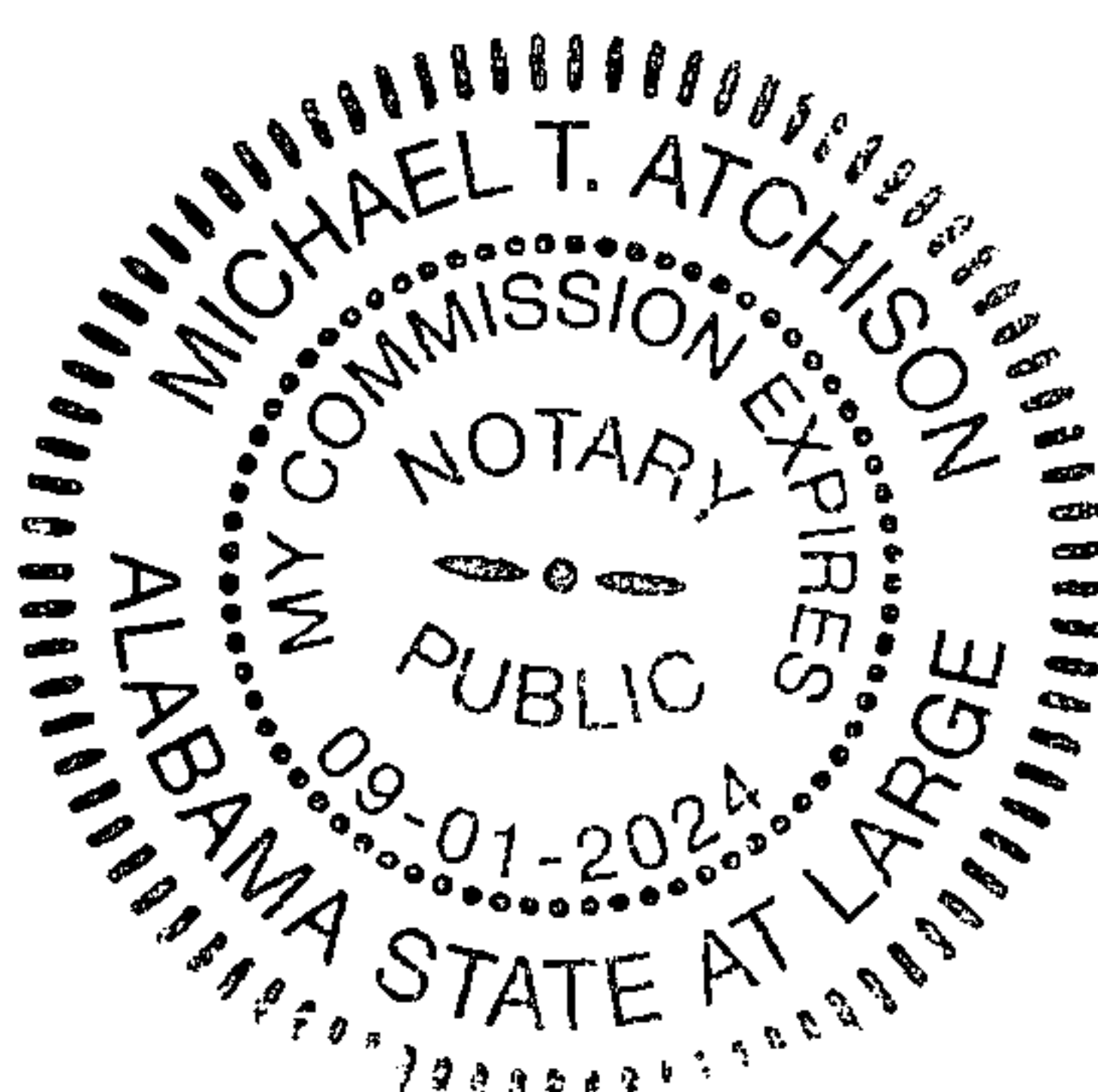
