PROVIDED.



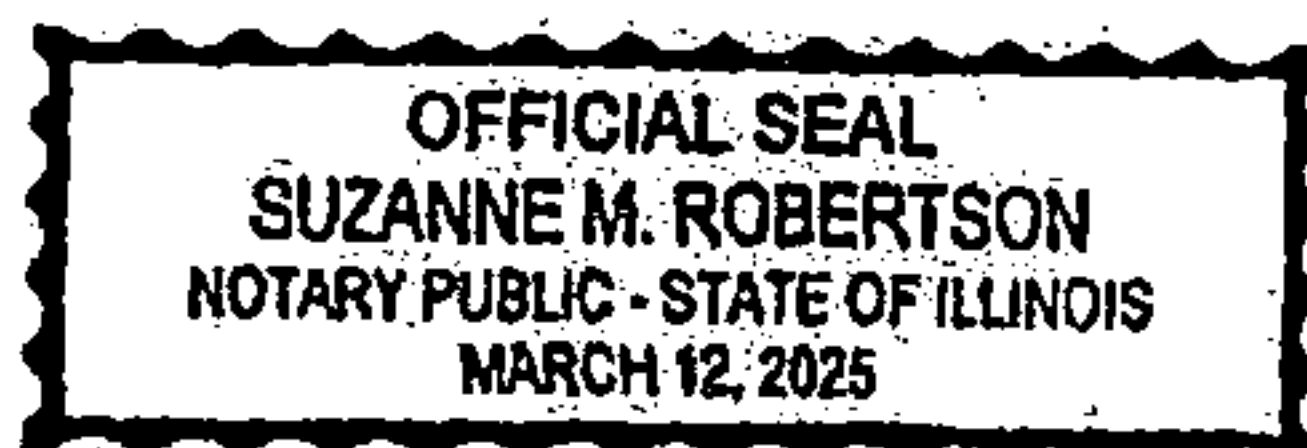
