That in consideration of the sum of ~~Fifteen Thousand Dollars and No Cents (\$15,000.00)~~ ^(134,400.00) the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Judy J. Gallups, a married woman** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Steven Johns and Dana Horton**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 1, of Marlin Gallups Family Subdivision, as recorded in Map Book 47, Page 23, in the Office of the Judge of Probate of Shelby County, Alabama.

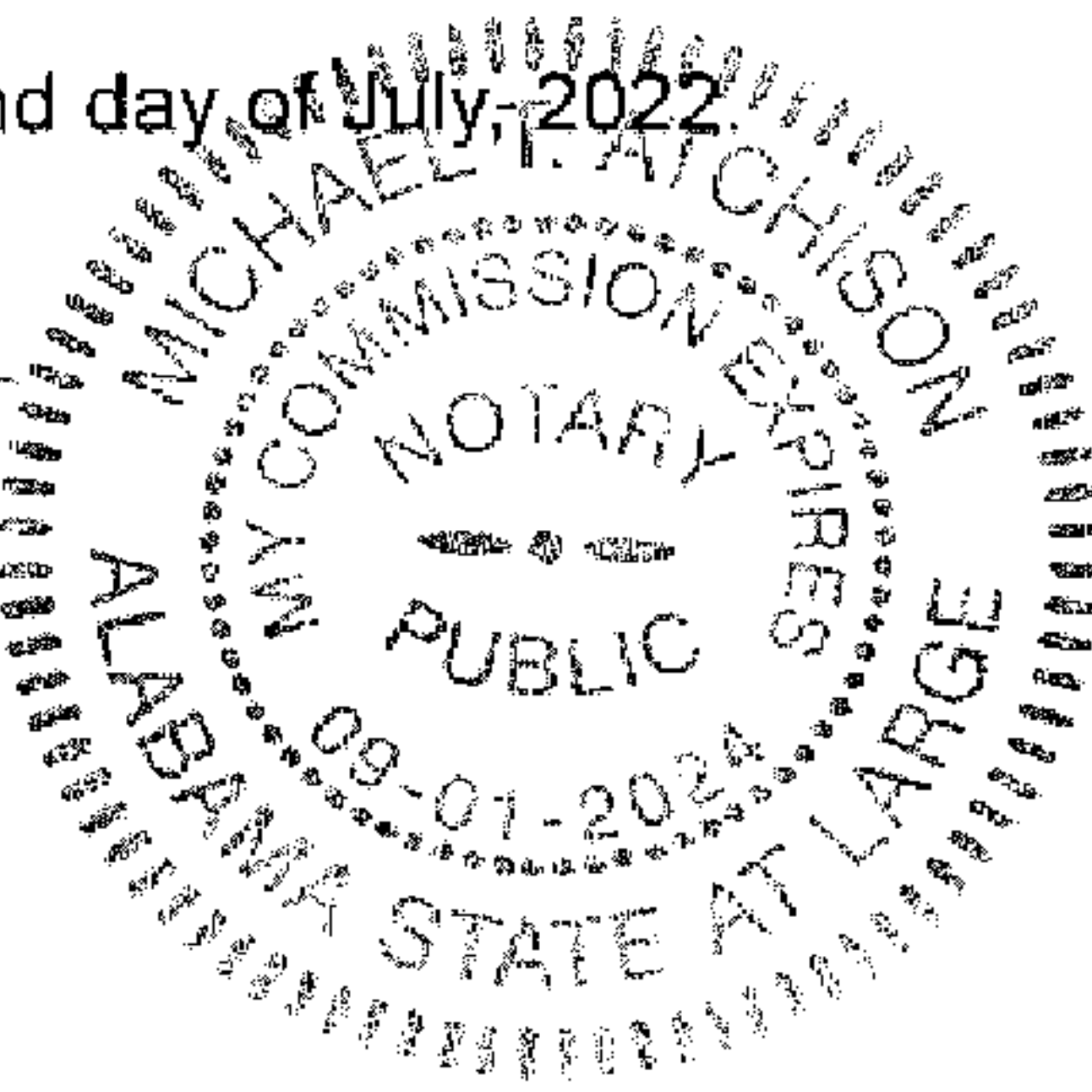
